The affiliating institution will return the amount through cheque/draft in favor of 'ICSSR' immediately.
- 3. The drawl of the monthly fellowship and the contingency grant will be governed by the rules of the affiliating Institute/University.
- **4.** The Fellow shall do whole time research work under an approved guide on the topic for which the fellowship was given by the Council. Any modification/change in the topic of research will need Council's prior approval.
