1. The sanction grants of Rs 2,07,000/- will be released as follows:

First Installment - 1,00,000/-
Second Installment - 92,000/-
Third Installment- 15,000/-

a) The first installment of Rs. 1,00,000/ will be released on receipt of enclosed 'Grant-in-aid Bill' duly completed, signed and Stamped by the Registrar/Principal/Director of the University/College/Institute, across a revenue stamp of usual denomination. (Please ignore, if already sent the Grant-in-aid bill)

b) The second installment of Rs.92,000/- will be released only after completion of six months and on receipt of detailed six-monthly progress report indicating clearly the work already done and the work left to be done through the supervisor and simple statement of expenditure incurred against the released first installment of grant and Grant in aid bill.

2) The renewal of the fellowship for the subsequent year will be subject to the annual progress report and statement of accounts for the entire grant released, to be found satisfactory. The renewal has to be sought before the expiry of the first year fellowship. Retrospective extension will not be sanctioned. Upon Extension, the third installment of Rs.15,000/- and First Installment of Rs 1,00,000/- for the Second Year will be released on receipt of Grant in aid bill for both the installments.

In between the period of first year's fellowship, if a scholar has left the fellowship to take up a job without prior permission of ICSSR he/she will have to refund the entire amount to the affiliating institution. The affiliating institution will return the amount through cheque/draft in favor of 'ICSSR' immediately.

3. The drawl of the monthly fellowship and the contingency grant will be governed by the rules of the affiliating Institute/University.

4. The Fellow shall do whole time research work under an approved guide on the topic for which the fellowship was given by the Council. Any modification/change in the topic of research will need Council's prior approval.

2. The sanctioned grant of Rs 2,07,000/- will be released in the following manner:

First Installment - 1,00,000/-
Second Installment - 92,000/-
Third Installment- 15,000/-

a) The first installment of Rs. 1,00,000/ will be released on receipt of the 'Grant-in-aid Bill' (proforma enclosed) duly completed, signed and stamped by the competent authority, viz., The Registrar/Principal/Director of the University/College/Institute, across a revenue stamp of usual denomination.

b) The second installment of Rs.92,000/- will be released only after completion of six months and on receipt of detailed six-monthly progress report clearly indicating the work already done and the work to be done as well as the simple statement of expenditure incurred against the first installment released, both duly forwarded by the supervisor. The Grant in aid bill for the amount of second installment should be duly forwarded by the competent authority.

3. The renewal of the Fellowship for the subsequent year shall be subject to the receipt of annual progress report and statement of accounts for the entire grant released, which should be duly found satisfactory. The renewal has to be sought before the expiry of the first year of the Fellowship. Retrospective Extension shall not be allowed. Upon Extension, the third installment of the first year as well as the first installment of the second year amounting to Rs 1,00,000/- will be released on receipt of Grant in aid bill for both the installments.

In case, the scholar leaves the Fellowship during the first year to take up a job, without prior approval of ICSSR, the scholar shall have to refund the entire amount of grant availed to the affiliating institution. You had applied in UGC-NET held on 10th JULY, 2016 for Junior Research Fellowship in ST category. I am pleased to inform you that you have qualified by securing marks at par with the qualifying cut-off for ST category. The tenure of fellowship is five years and it commences from the date of declaration of NET result, i.e., 21st November 2016 (or) from the date of admission under M.Phil/Ph.D. (or) from the date of joining M.Phil/Ph.D. programme, whichever is later. The summary of financial assistance offered under the scheme is mentioned at Annexure I available on www.ugc.ac.in/netjrf along with other Annexures.

The Awardee is required to get admission and registration for regular and full time M.Phil/Ph.D. course in a University/Institution/College recognized by UGC at the first available opportunity but not later than two years from the date of issue of this award letter. The Universities/ Colleges/ Institutions will submit the master data of the awardee on the portal with a unique user profile of the University/ Institution/ College (user name and password already provided to the University, Institution/ College). The Universities/Institutions/ Colleges shall update the information in the master data (regarding continuation, HRA, up-gradation, resignation etc.) of the beneficiaries quarterly. Based on the master data received from the concerned Universities/Institutions/Colleges the payment of the fellowship will be made to the beneficiaries.

It may also be noted that UGC has proposed to link "AADHAAR" with students bank account so that there can be direct cash transfer and effective disbursement of fellowship into bank account of the student. In this regard Secretary, UGC has already requested the universities to help students in Aadhaar enrolment vide his D.O. No. F.14-34/2011 (C/P-II) dated 11.01.2013.


