The tea developed by him has wide acceptance in Columbia, Canada where he supplies tea regularly. He also exported tea to Egypt, Hong Kong, Japan and Greece.

Preamble:

University of Science & Technology, Meghalaya, having its registered office at Techno City, 9th Mile, Baridua, Meghalaya, hereinafter called "USTM", is established by an act of Legislative Assembly of Meghalaya State in 2008. The objective of USTM is to impart world class education exploring opportunities and talents of north east region, thereby, creating cutting edge research centre and build a Knowledge Capital for societal development. USTM is an upcoming university with minimal resources and high ambition trying for academic excellence.

Understanding:

1. USTM becomes a partner of MEEN MOHAN ORGANIC TEA GARDEN for conducting research for mutual exchange of expertise and create a framework for collaboration for tea cultivation particularly organic cultivation.
2. USTM will provide professional consultancy for promotion and marketing of MEEN MOHAN ORGANIC TEA GARDEN.
3. Help MEEN MOHAN ORGANIC TEA GARDEN in developing innovative ideas for their growth and development.
4. Initial 3 years University will extend necessary financial support for all above mentioned activities in furtherance of the mission of MEEN MOHAN ORGANIC TEA GARDEN.
5. MEEN MOHAN ORGANIC TEA GARDEN will not have any financial liabilities in executing the above activities.
6. University will introduce a fellowship and for conducting research at the garden and MEEN MOHAN ORGANIC TEA GARDEN will extend necessary support.
7. Display unit of the product will be arranged at the University and MEEN MOHAN ORGANIC TEA GARDEN will provide tea at subsidized rate for display and for complimentary offer to dignitaries.
8. MEEN MOHAN ORGANIC TEA GARDEN will provide space at the garden for any official/research activities.

This agreement shall be the sole repository of terms agreed to between the parties and amendment shall take effect as and when required by concurrence of both parties. The agreement will be binding on MEEN MOHAN ORGANIC TEA GARDEN and USTM unless such amendment is authorized by MEEN MOHAN ORGANIC TEA GARDEN and USTM and is recorded in writing and signed by both parties. Both parties shall be consulted before any such amendment is brought into effect.

This Memorandum of Understanding will be effective upon signature by both the Chief Executive Officers for a period of five years, at which time the same will be reviewed for possible renewal for further five-year period. Either party may, on three (03) months notice in writing, terminate the MoU in advance of its normal expiration or request the recognition of its conditions.
