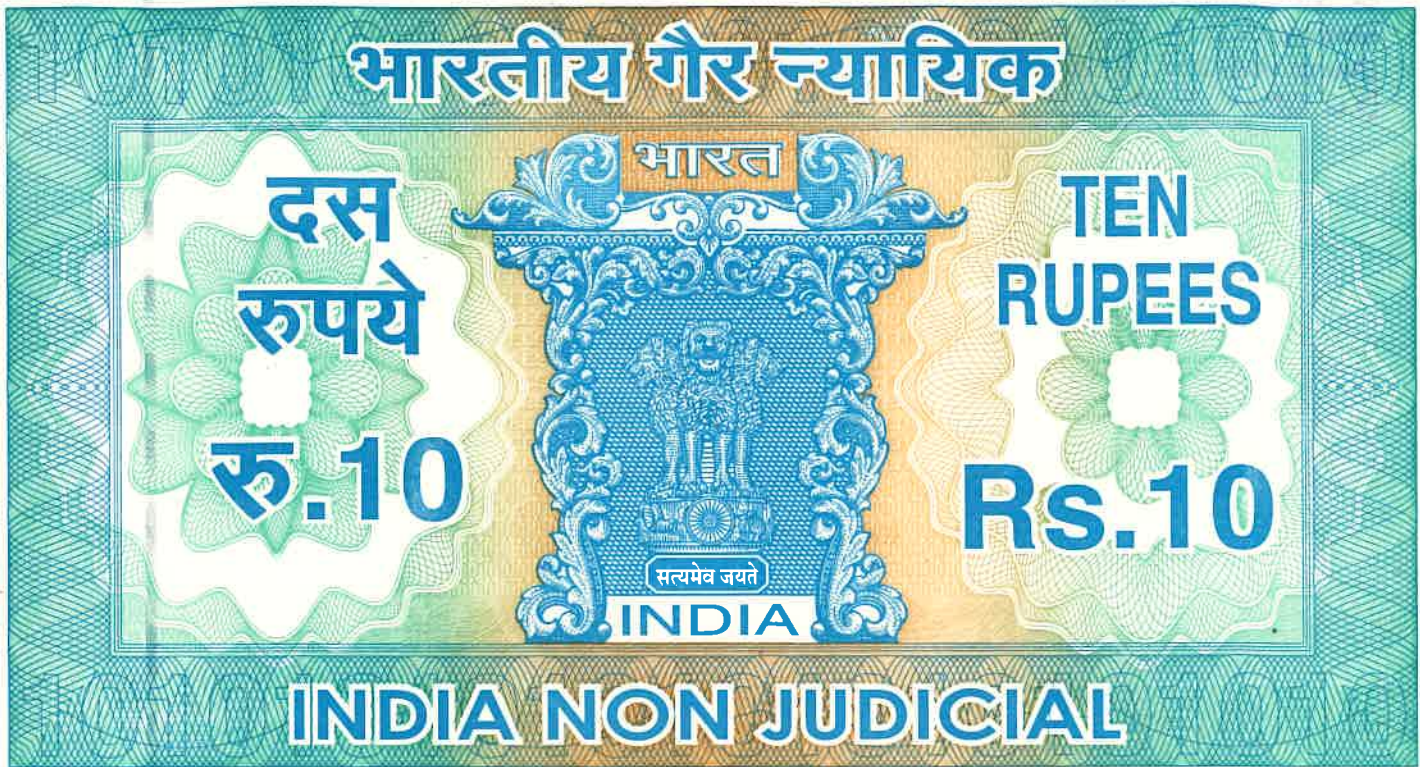

**Memorandum of Understanding
between
CSIR- North East Institute of Science & Technology, Jorhat, Assam
and
University of Science & Technology, Meghalaya**

This Memorandum of Understanding (MoU) is executed on this day^{16th} of October, Two Thousand Nineteen between CSIR-North East Institute of Science and Technology, Jorhat 785006, Assam which is a constituent unit of the Council of Scientific and Industrial Research, having its registered office at Anusandhan Bhavan, 2, Rafi Marg, New Delhi – 110 001, (hereinafter referred to as CSIR-NEIST) through its authorized representative, the Director, of the one part;

And

University of Science & Technology, Meghalaya (USTM) is the first private Science and Technology University in the North-Eastern Region of India. The University is located in Baridua, 9th Mile, Ri-Bhoi, Meghalaya-793101 (hereinafter referred to as USTM), through its authorized representative, the Chancellor, USTM, of the other part.

1. Preamble :

CSIR-North East Institute of Science and Technology (CSIR-NEIST), Jorhat, Assam, a constituent establishment of Council of Scientific and Industrial Research, a society registered under the Societies Registration Act XXI of 1860 and having its registered office at Anushandhan Bhawan, 2, Rafi Marg, New Delhi 110 001.

The University of Science & Technology, Meghalaya was established under the provisions of the University of Science & Technology, Meghalaya Act (No.6 of 2008) enacted by the Legislative Assembly of Meghalaya and notified vide Gazette Notification No. LL (B) 87/2008/21, dated 02.12.2008 of Government of Meghalaya. USTM is empowered by University Grants Commission to award degrees as specified under Section 22 of UGC Act, 1956.

Both CSIR-NEIST and USTM shares a common desire to explore, extend and strengthen the functional relationship between the University and the National Scientific Institute. USTM and CSIR-NEIST in order to share the facilities and expertise available in each other's institution herewith sign a Memorandum of Understanding.

2. Purpose and Objectives:

The purpose of this Agreement is to promote cooperation in scientific education and research between USTM and CSIR-NEIST. The mutual collaboration will enable the utilization of each other's strengths in teaching and research, which in turn, will mutually benefit the students and faculty and scientific members of both the organizations and to create a framework for such a platform of collaboration with specific objectives as given below:

- a. To establish a close linkage and functional coordination between CSIR-NEIST and USTM.
- b. To recognize CSIR-NEIST as accredited research institute of USTM.
- c. To facilitate the Bachelors/Masters/PhD students of USTM to conduct project works in CSIR-NEIST under the supervision of the scientists of CSIR-NEIST/Joint supervision by the faculty members the both institutes.
- d. To consider the CSIR-NEIST professional as accredited supervisor/guide/instructor for USTM teaching and research programme.
- e. To facilitate joint seeking of funds and conduct of research, submission of projects for research and development in the fields of mutual interest, exchange of visiting research scholars including advanced graduate students.
- f. Opportunities for faculty and staff development and exchange through training programmes.
- g. To facilitate creation/development of new experimental and research/training facilities through mutual co-operation of CSIR-NEIST and USTM through exchange of experts, etc.
- h. On the mutual agreement, specialized and short duration refresher courses/training programmes on the topics of interest to the industry/academia can be jointly offered at CSIR-NEIST or USTM. The resources for such activities shall be shared.



- i. To facilitate other form of cooperation like hosting conferences, seminars, etc. mutually agreed between CSIR-NEIST and USTM.
- j. Any intellectual property arising out of the joint intellectual input under a collaborative R&D project will be held jointly, filing and maintenance cost of which shall also be shared equally. The responsibility of filing and maintaining the intellectual property shall be vest with CSIR on a case to case basis. However, in the event of licensing of the IP for commercialization by CSIR-NEIST or USTM to any third party, the terms of such release will be decided mutually and the release will be covered by a separate agreement and also money accrued will be shared between CSIR-NEIST and USTM at a proportion to be mutually decided from case to case basis after deducting the cost of patenting borne by CSIR on behalf of USTM. In case USTM does not want to be a party to the intellectual property, Director, CSIR-NEIST shall take an appropriate decision regarding its filing and utilization. USTM shall not file any application for seeking Intellectual Property Rights on its own name or in the name of its associates or any other person on any matter relating to the information gathered/disclosed to it by CSIR-NEIST.
- k. CSIR-NEIST and USTM shall consult each other for any publication in respect of any project/course work, These publications shall be in the name of research worker, wherein it will be duly acknowledged.
- l. To facilitate the students of USTM for experimental work at CSIR-NEIST in selected areas.
- m. Any expenditure incurred through the joint programmes will be borne as per mutual agreement.

ROLE OF CSIR-NEIST, JORHAT

- 1. To provide infrastructural and relevant facilities for the successful realization of the above mentioned objectives.
- 2. To facilitate the organization of different programmes in the Institute premises through mutual discussion.
- 3. The students and faculty members of USTM to access the library and instrumentation facility of CSIR-NEIST.

ROLE OF USTM

- 1. To provide infrastructural and relevant facilities for the successful realization of the above mentioned objectives.
- 2. To facilitate the organization of different programmes in the Institute premises through mutual discussion.
- 3. The students and faculty members of CSIR-NEIST to access the library and instrumentation facility of USTM



3. Review of MoU

- i. These arrangements shall be effective for a period of five years commencing from the date of signing of this MoU and its continuance will be subject to review on expiry of agreed period of five years.
- ii. The MoU can be amended in writing by mutual consent of both the parties.
- iii. The MoU may be terminated by either party by providing 90 days written notice.
- iv. Any disputes arising out of the arrangement shall be settled by mutual negotiation between two parties.

The parties have jointly signed/executed this Memorandum of Understanding in two copies on date and year written above.



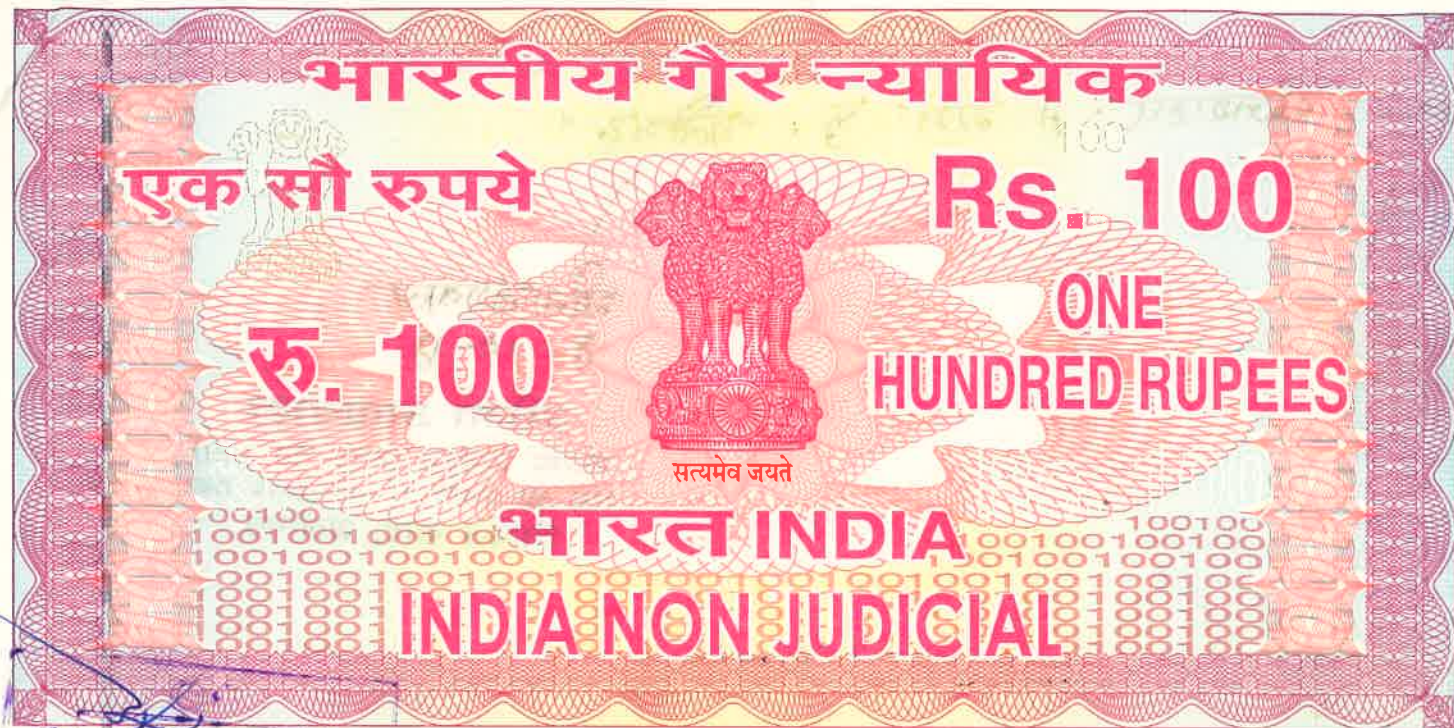

Memorandum of Understanding (MoU)

This Memorandum of Understanding (MoU) is executed on 15th Day of October, 2018 between Aligarh Muslim University, Aligarh - as the First Part;

&

University of Science and Technology, 9th Mile, Baridua, Meghalaya - as the Second part; herein together referred to as "the Universities".

Aligarh Muslim University, having its registered office at Aligarh, India herein after called "AMU", is a Central University, established by an Act of the Parliament known as Aligarh Muslim University Act, 1920.

And

University of Science & Technology, Meghalaya, having its registered office at Techno City, 9th Mile, Baridua, Meghalaya, hereinafter called "USTM", is established by an act of Legislative Assembly of Meghalaya State in 2008. The objective of USTM is to impart world class education



exploring opportunities and talents of north east region, thereby, creating cutting edge research centre and build a Knowledge Capital for societal development. **USTM** is an upcoming university with minimal resources and high ambition trying for academic excellence.

Whereas **USTM** has requested **AMU** to mentor the upcoming university to achieve its objectives, through various programmes for the academic promotion and administrative guidance with the following identified but not limited to,

1. **Award of Ph. D Degrees** - The students who would like to register for Ph. D at USTM will be given option to opt for joint supervision - one from USTM and a co-Guide from AMU. Those faculties of USTM who are interested to be recognised as supervisor / Co-supervisor of AMU, shall apply for such recognition to the Controller of Examinations, Aligarh Muslim University. The competent authority of Aligarh Muslim University will consider such request on priority as per provisions of AMU rules..
2. **AMU Faculty support to USTM** - Identified Faculty of AMU in the areas of Biotechnology, Chemistry, Environment Science, Business Administration, Social Sciences shall take classes at AMU for the identified courses and syllabus with mutual consultation by USTM faculty with AMU Faculty. The AMU faculty, who have agreed and take classes at USTM, shall be provided with Transport, Accommodation facilities and an honorarium per lecture as per USTM norms.
3. **AMU to host selected USTM Students for short period** - AMU will host students Identified by USTM in different disciplines at AMU for 10-15 days for attending special classes or classes regular with USTM students in class rooms and laboratories as per the plan of AMU to impart greater exposure in the respective subjects. During the period, AMU will provide hostel accommodation to USTM students.
4. **Final Year Projects of USTM Students** - AMU will permit some selected final year students of USTM on mutual consultation, to do their Project Work at AMU.



5. **Joint Submission of Collaborative Projects** - AMU faculty will involve some of the selected faculty of USTM to be Co-investigator in their project proposals for funding and vice versa.
6. **Seminars/ symposia/workshop to be jointly organized** - Some of the selected seminars / workshops / symposiums organized by the various departments of AMU and USTM either by faculty or students to be held jointly on mutual consultation by the respective faculty on case to case basis.
7. **Organize the visitors of AMU to visit USTM** - AMU will try to request and facilitate the visitors / guests coming to AMU to visit USTM.
8. **Guidance in University Administration** - USTM is an upcoming university and a beginner in many aspects. AMU will provide guidance to USTM staff in Administration in areas like, examination, admissions, recruitment of staff and organizing Convocation.
9. **Guidance in infrastructure development** - AMU will guide USTM in upgrading of **university infrastructure** like laboratories, equipments, library, class rooms, recreational facilities, hostels, campus maintenance by providing necessary specifications and operational guidance where required.
10. **Sports promotion** - AMU and USTM will conduct some inter university friendly matches in selected sports on mutual consultation.
11. **Arbitration:** "In the event of any dispute, difference or question arising out of or touching upon or concerning this agreement, the same shall be resolved by both parties through discussions. However, in case of such disputes that cannot be resolved by both parties, then it shall be referred for arbitration to Vice Chancellor of AMU. The decision of the Arbitrator shall be final and binding on BOTH PARTIES and no suit shall lie in any Civil Court in respect of the matter decided by arbitration and the provisions of the Arbitration and Conciliation Act (1996) of India shall apply to the same."





12. Both **AMU** and **USTM** agree that any information which is exchanged pursuant to this Memorandum of Understanding will be kept strictly confidential and used solely for the purpose, covered by this Memorandum of Understanding, unless such information was obtained by a third party who does not have an obligation of confidentiality toward the information-disclosing party and entered public domain.

Incidental expenses, if any with respect to the activities mentioned above will be met by **USTM**. Any expenditure w.r.t. visit of the **AMU** staff to **USTM** will be met by **USTM**.

Subject to clauses below, both the **Universities** may amend this Memorandum of Understanding by mutual consent in writing. Any amendment agreed by the Universities shall come into effect the date determined by the signing Universities on potential areas.


This Memorandum of Understanding shall enter into force on the date of signing and shall initially be valid for a period of three years. Thereafter, the **Universities** shall agree on mutual consent on the continued validity of this Memorandum of Understanding. *However, AMU has freedom to continue or discontinue the MOU at its own discretion*

The Universities agree that this Memorandum of Understanding shall enter into force on the basis of goodwill and shall not be legally bound. Nothing mentioned in this Memorandum of Understanding shall deem constitute partnership between the signing Universities appointing one party as an agent of the other. This Memorandum of Understanding will be effective upon signature by both the Chief Executive Officers for a period of three years, at which time will be reviewed for possible renewal for further three-year period. Either party may, on three (03) months notice in writing, terminate the MOU in advance of its normal expiration or request the recognition of its conditions.



- 2.1 Exchange Visits by students, faculty and administrators for study and research, teaching and discussions in accordance with regulations of both governments and universities;
- 2.2 Exchange of materials in education and research, publications, and academic information, Instruction and cultural programmes;
- 2.3 Institution of fellowships in furtherance of the above objective.
- 2.4 Exchange of information including, but not limited to, exchange of library materials and research publications;
- 2.5 Joint research projects and programmes related to global education in the following areas and not limited to;
 - 2.5.1 Peace and conflict transformation;
 - 2.5.2 Water resource and solid waste management
 - 2.5.3 Ecological issues, including Sunderban area development
 - 2.5.4 Women empowerment
 - 2.5.5 Micro finance
- 2.6 Any other issues related to the overall spread and promotion of education and for all round development of both the countries in specified areas that may be applicable by rule of law of the respective lands.
3. Joint ventures by both the Universities that may be taken up and promoted as per the need of the changing scenario.
4. To gear up the process of activities of both the Varsities to wear a global outlook and bring about transformation in the Education System transparently for achieving global standards and to reap optimized standardized outputs.
5. Both parties understand that all financial arrangements will have to be negotiated as the need arises, and will depend on the availability of funds.
6. Specific details for the implementation of these activities in regards to this memorandum will be developed mutually for specific projects.

7. In order to enhance the efficiency of their cooperative activities, the UDB and the USTM agree that it shall be possible to introduce changes and additions to the Agreement by means of mutually agreed upon additional written clauses. This memorandum will have, from time to time, annexes attached to it with regard to these specific projects. These provisions may be added at any time by mutual agreement made in writing.
8. All activities developed under the auspices of this Agreement with the procedures, policies and practices, of each University as well as all applicable laws and regulations, including applicable portions of the Export Control Acts of India and Bangladesh.
9. Both institutions acknowledge that the visit by faculty and students from one institution to the other shall be subject to Entry and Visa Regulations of the India and Bangladesh and shall comply with regulations and policies of the UDB and the USTM.
10. This Agreement will be effective for a period of five years, effective from the date of signing. At the end of each five-year period, this Agreement will be automatically renewed by mutual agreement for an additional five years, unless the UDB and the USTM provide written notification of a decision of non-renewal prior to the expiration date. A minimum period of six months' notice will be required from each party wishing to terminate the Agreement. In the event of termination, all commitments to students and scholars participating in the programmes will be honoured by relevant parties. Where the Agreement continues to be active, the two institutions agree to review it every two years from the date thereof.

MEMORANDUM OF UNDERSTANDING

BETWEEN

JAMIA MILLIA ISLAMIA, NEW DELHI, INDIA

AND

UNIVERSITY OF SCIENCE AND TECHNOLOGY, MEGHALAYA

First party: JAMIA MILLIA ISLAMIA, Jamia Nagar, New Delhi – 110025 hereinafter referred to as **JMI** is a Centre University under an enactment of the Parliament of India (i.e. the Jamia Millia Islamia Act, 1988) and is a body corporate with a perpetual succession. The objective of the University is to strive to provide employment oriented higher education and promote research.

Second party: University of Science & Technology, Meghalaya, having its registered office at Techno City, 9th Mile, Baridua, Meghalaya, hereinafter called "**USTM**", is established by an act of Legislative Assembly of Meghalaya State in 2008 promoted by Education Research and Development Foundation, Guwahati. The objective of USTM is to impart world class education exploring opportunities and talents of north east region, thereby, creating cutting edge research centre and build a Knowledge Capital for societal development. USTM is an upcoming university with minimal resources and high ambition trying for academic excellence.

Whereas USTM has requested JMI to mentor the upcoming university to achieve its objectives, through various programmes for the academic promotion and administrative guidance with the following identified but not limited to,

Article 1 - To develop the following collaborative activities in academic area of mutual interest

1. **Award of Ph.D Degrees** – The students who would like to register for Ph.D at USTM will be given option to opt for joint supervision – one from USTM and one from JMI subject to availability of vacancy as per UGC guidelines. Those faculties of USTM who are interested to be recognized

as Supervisor / Co-supervisor of JMI, shall apply for such recognition to the Controller of Examinations, Jamia Millia Islamia. The competent authority of Jamia Millia Islamia will consider such request on priority as per provisions of JMI rules.

2. **JMI Faculty support to USTM** – Identify Faculty of JMI in the areas of Biotechnology, Chemistry, Environment Science, Business Administration, Social Sciences and Engineering shall take classes at USTM for the identified courses and syllabus with mutual consultation by USTM faculty with JMI Faculty. The JMI faculty, who would be assigned duties at USTM, shall be provided with Transport, Accommodation facilities and an honorarium per lecture as per USTM norms.
3. **JMI to host selected USTM Students for short period** – JMI will host students Identified by USTM in different disciplines at JMI for 10-15 days for attending special classes or regular classes with JMI students in class rooms and laboratories as per the plan of JMI to impart greater exposure in the respective subjects. During the period, JMI will provide hostel accommodation to USTM. The cost of stay in the hostel will be borne either by the students themselves or by USTM.
4. **Final Year Projects of USTM Students** – JMI will permit some selected final year students of USTM on mutual consultation, to do their project work at JMI.
5. **Joint Submission of Collaborative Projects** – JMI faculty will involve some of the selected faculty of USTM to be Co-Investigator in their project proposals for funding and vice versa.
6. **Seminars / symposia / workshop to be jointly organized** – Some of the selected seminars / workshops / symposiums organized by the various departments of JMI and USTM either by faculty or students to be held jointly by mutual consultation by the respective faculty on case to case basis.
7. **Organize the visitors of JMI to visit USTM** – JMI will try to request and facilitate the visitors / guests coming to JMI to visit USTM.
8. **Guidance in University Administration** – USTM is an upcoming university and a beginner in many aspects. JMI will provide guidance to USTM staff in Administration in areas like, examination, admission, recruitment of staff and organizing convocation.

9. **Guidance in infrastructure development** – JMI will guide USTM in upgrading of university infrastructure like laboratories, equipments, library, class rooms, recreational facilities, hostels, campus maintenance by providing necessary specifications and operational guidance where required.

10. **Sports promotion** – JMI and USTM will conduct some inter university friendly matches in selected sports by mutual consultation.

Article 2 – Both JMI and USTM agree that any information which is exchanged pursuant to this Memorandum of Understanding will be kept strictly confidential and used solely for the purpose, covered by this Memorandum of Understanding, unless such information obtained by a third party who does not have an obligation of confidentiality toward the information-disclosing party and entered public domain.

Article 3 – Incidental expenses, if any with respect to the activities mentioned above will be borne by USTM. Any expenditure with regard to the visit of the JMI staff to USTM will be borne by USTM.

Article 4 – Subject to clauses below, both the Universities may amend this Memorandum of Understanding by mutual consent in writing. Any amendment agreed by the Universities shall come into effect the date determined by the signing Universities on potential areas.

Article 5 – This Memorandum of Understanding shall enter into force on the date of signing and shall initially be valid for a period of three years.

Thereafter, the Universities shall agree on mutual consent on the continued validity of this Memorandum of Understanding. However, JMI has freedom to continue or discontinue the MOU at its own discretion.

Article 6 – The Universities agree that this Memorandum of Understanding shall enter into force on the basis of goodwill and shall have no legal binding. Nothing mentioned in this Memorandum of Understanding shall deem to constitute partnership between the signing Universities appointing one party as an agent of the other. This Memorandum of Understanding will be effective upon signature by both the Vice-Chancellors for a period of three years. This time will be reviewed for possible renewal for further three-year period. Either party may, on three months notice in writing terminate the MOU in advance of its normal expiration.

Article 7 – This Memorandum of Undertaking shall require the ratification of the competent Academic / Executive body of the First Party Jamia Millia Islamia and the concerned Academic / Executive body of the Second party University of Science & Technology, Meghalaya.

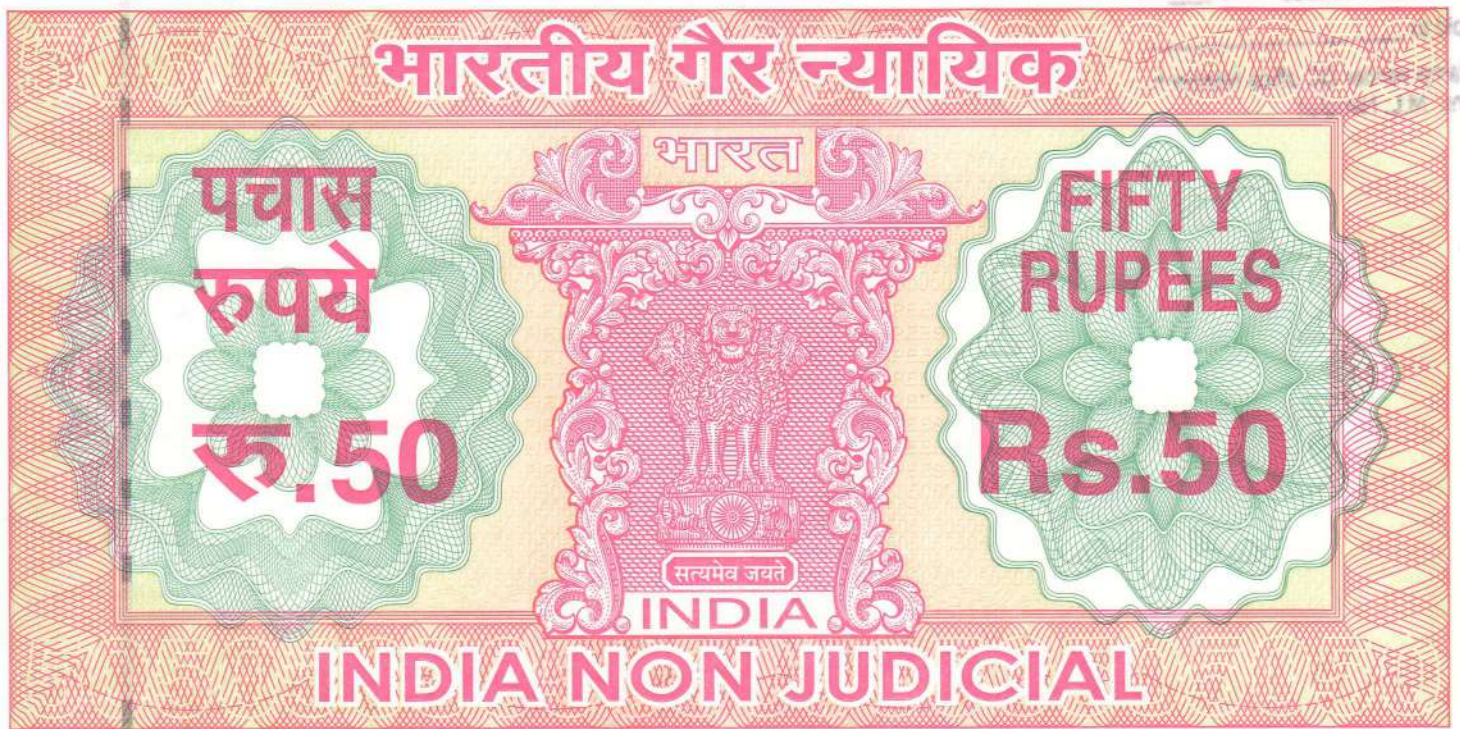

PREAMBLE

University of Science and Technology Meghalaya

University of Science & Technology, Meghalaya, having its registered office at Techno City, 9th Mile, Baridua, Meghalaya, hereinafter called "USTM", is established by an act of Legislative Assembly of Meghalaya State in 2008. The objective of USTM is to impart world class education exploring opportunities and talents of north east region, thereby, creating cutting edge research centre and build a Knowledge Capital for societal development. **USTM** is an upcoming university with minimal resources and high ambition trying for academic excellence.

Cyberlaw Univ

Cyberlaw Univ is an online Cyberlaw education platform, that is specifically dedicated to the study of Cyberlaw and related legal issues. Cyberlaw Univ aims to provide various courses and diplomas that would make the participants more aware about the various legal issues pertaining to cyberspace, Internet and the World Wide Web. Cyberlaw Univ is committed to bring the constantly evolving trends pertaining to legal issues impacting computers, computer systems, computer networks, communication devices as also data and information in the electronic form, to the participants of its various courses. Cyberlaw Univ is committed to the principles of transparency and further growth of enabling structures, frameworks and principles of Cyberlaw. Cyber Law University, as a sole proprietorship, has its office at New Delhi, India.

Cyberlaw Univ

- empowers all stakeholders in the digital ecosystem, through impacting education and capacity building on various areas in the intersection of law and technology , including through teacher training, research, course development and collaborative projects;
- supports institutions in their efforts to introduce Cyberlaw and cyberspace related issues in education institutions including higher education institutions and support the integration of relevant and contextual standards and structures;
- encourages students to enhance their skill sets by sensitizing them to best legal and technical standards and practices of nations, companies and organizations that have become successful in dealing with various challenges of cyberspace;
- provides professionals with educational materials adapted to their profession to grow a deeper understanding of law and technology in their context (for them to use such knowledge and skill sets in their practical day to day working);
- contributes to achieving the United Nations Sustainable Development Goals(SDG's).

PURPOSE

- I. **The Purpose** of this Memorandum of Understanding (hereinafter referred to as MOU, for the sake of brevity) between University of Science and Technology Meghalaya and "Cyberlaw Univ" is to create synergies and to strengthen the implementation of the objectives of the respective organizations. This MOU is rooted in the shared goal of the partners to promote the cause of Cyberlaw education as also education and capacity building on all aspects concerning Cyberspace , Internet, World Wide Web, , emerging technologies and all elements on the intersection of law, technology and cyber space, through this partnership and is built upon the respective capacities and competencies of the partners.

Based on the above, University of Science and Technology Meghalaya and Cyberlaws.Net (referred individually as 'party' and jointly as 'parties') enter into this MoU.

NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSETH AS UNDER:-

ARTICLE 1- SCOPE AND CONTENTS OF MOU

University of Science and Technology Meghalaya and 'Cyberlaw Univ' hereby agree to:

- a) Promote products such as online courses of Cyberlaw Univ for teachers and students and online and/or offline courses of Cyberlaw Univ via Cyberlaw Univ website and such other technical modes as feasible, with the intellectual property rights therein vesting in Cyberlaw Univ ;
- b) Develop joint projects in courses, research and publications, paper competitions and internships;
- c) Collaborate and share credits for each other's courses, wherever applicable;
- d) Work together in developing Joint and articulated degree programs, diplomas, certificates programs and courses;
- e) Engage in joint teaching, research, or cultural activity;
- f) Encourage mobility of students between institutions;
- g) Encourage Staff professional development;
- h) Be committed to sharing and creation of educational materials and resources.
- i) Organize lectures and conferences;
- j) Invite each other to participate in events and multi-partner projects;
- k) Cooperate on other projects of mutual interest;
- l) Promote each other's activities in their respective networks and websites, when agreed to by both parties;
- m) Mention each other as project/cooperation partners on their respective websites and in the actual world;
- n) To work together for developing joint proposals for submission to international agencies and organizations; and
- o) To work together in establishing bridges and bonds of understanding with other stakeholders in the educational and digital ecosystem.

ARTICLE 2- REVENUE SHARING FOR EXISTING COURSES OF CYBERLAW UNIVERSITY.

a) Both the parties agree that the existing Cyberlaws.Net courses shall be offered to government and non-government officers, policy makers, law enforcement agencies, other governmental and non-governmental agencies, professionals, teachers and students within University of Science and Technology Meghalaya and outsiders on a revenue share model. The revenue share for jointly offering the existing Cyberlaws.Net courses, shall be split in the ratio of 60 :40 respectively (Cyberlaws.Net getting 60% share and University of Science and Technology Meghalaya getting 40% share) of course fee revenue received per student. The online admission fees and the evaluation fees will be split as per the aforesaid revenue share ratio (Cyberlaws.Net getting 60% share and University of Science and Technology Meghalaya getting 40% share)

b) Any specific activity developed under this Memorandum of Understanding shall be detailed in a subsequent agreement, signed by each institution's authorized signatory, which will describe the scope of the proposed activity, intended outcomes, budget, and responsible departments or individuals. All activities shall be subject to the availability of funds and the approval of each institution's authorized representatives.

Food Industry Capacity & Skill Initiative (FICSI) is the Sector Skill Council for the "Food Processing" Sector and has been formed under the aegis of the National Skill Development Council (NSDC) and Federation of Chambers of Commerce of India (FICCI) as an initiative to promote skill development. FICSI' functions as an autonomous body and its main charter/objectives are as under:

- Identify the skill development needs of the "Food Processing" Industry.
- Set National Occupational Standards (NOS).
- Approve curriculum for training.
- Execute "Train the Trainer" programmes.
- Accredite Training Institutes imparting training in "Food Processing" related job roles.
- Set assessment and certification processes.

It may support the institute in development of course curriculum related to skill based program in food processing as per guideline and institute will also support FICSI with its technical expertise to develop and validate QP, curriculum and course content.

E. Collaborative Efforts for furthering in skilling

Institute will teach NSQF aligned job roles under the skill component and this will include on-the-Job training/ Apprenticeship / practical classes in laboratories / workshops/ internship which will give candidate a better exposure in the job market. FICSI has already developed a job portal for such candidates where candidates' information can be shared with the industry for placement purpose. University of Science and Technology, Meghalaya will share the information of eligible students to feed into the job portal.

F. Manpower & Infrastructure required

The existing infrastructure and manpower of the Parties will be used for the implementation of the collaborative activities to the extent agreed by each party. Within 30 days both Parties will nominate a Liaison Officer for coordinating the collaborative activities.

H. Duration of MoU

This memorandum of understanding shall be deemed to have come into force w.e.f the date of signing and shall remain in force for 3 years.

I. Entire agreement

This MoU shall constitute of the entire understanding between the Parties with respect to the subject matter hereof and supersede all prior agreements or understandings of the Parties relating thereto.

J. Amendments

No modifications or amendments of any terms or conditions of this understanding shall be effective unless made in writing and signed by the authorized representatives of the parties.

K. Arbitration / Dispute Settlement

In case of any dispute that may arise during or after project execution, the matter would be settled mutually.

L. Notices

All notices required or permitted by, or made pursuant to this MoU shall be in writing and sent by registered post to the following address:

M. Implementation

The parties shall review the Implementation and the application of this MoU through a joint committee in every 3 months alternatively. This Implementation Committee shall meet as required at either of parties work places.

N. Assignment

This MoU is based on the professional competence and expertise of each party and hence neither party shall transfer or assign this MoU or rights or obligations arising hereunder, either wholly or in part, to any third party.

N. General Provisions

1. The parties shall bear their respective costs of carrying out the collaborative activities envisaged under this MoU.

Neither party shall make a claim against the other party for any expenditure, unless such expenditure has been agreed upon in writing between the parties.

2. Either party reserves the right to terminate this MoU subject to 60 days prior written notice to the other party hereto. Any program or activity that was already commenced shall survive the termination of this MoU and be completed to the best of both parties abilities pursuant and subject to the terms of this MoU.

O. Non – exclusivity


The relationship of the parties under this MoU shall be non – exclusive and both parties are free to pursue other agreement or collaboration of any kind. 



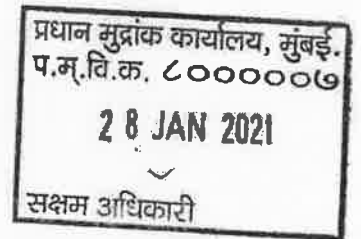

The **University of Science & Technology, Meghalaya (USTM)** whose address is Techno City, Kling Road, Baridua, 9th Mile, Ri-Bhoi, Meghalaya-793101.



WHEREAS **Foundation for Innovative Packaging and Sustainability (FIPS)** is a non-government, not-for-profit Organisation registered under Section 8(1) of the Companies Act, 2013 (CIN : U85300MH2020NPL345503), established on 7th September, 2020 with a vision to provide Sustainable solutions to the targeted group of Society and industries through Scientific and innovative Packaging technology and to create awareness for circular economy to save the Planet. USTM has also received necessary approval from AICTE, New Delhi; NCTE, ERC, Bhubaneswar, Pharmacy Council of India to run MBA, B.Ed. & B. Pharm courses respectively.

The university has been involved for nearly 10 years in fulfilling the aspirations of young mind by imparting quality education. AND WHEREAS, **FIPS & USTM**, collectively referred to as the Parties, inspired by their common objectives to promote innovative and sustainable Solution through **Human Resource Development Technology** in the field of "Sustainable Packaging for Food Products" have decided to enter into this MOU and agree as herein contained:

Article 1: Background & Purpose

- The parties of this Memorandum of Understanding have agreed in principle to promote Human resource Development by organising **Collaborative Certificate Programme** in "**Sustainable Packaging for food Products**" where FIPS would provide Faculty Support with a professional fees (to be mutually agreed) for conducting Certificate Course and other module of Training Program for the benefit of the students of Food Science & Technology with mutual financial benefits. The students would be benefitted to get exposure in this specialised field of Sustainable Packaging for Food Products which would help them in their Career Development. FIPS would also get involved with USTM to support for any research projects related to "Sustainable Packaging" in order to make "Win-Win" situation for both the organisation. Accordingly, FIPS will mention the name and Logo of USTM as "Collaborative Institutions" in Website as well as in other promotional documents.

Article 2: Statement of Activities & Responsibilities

The parties, through this MOU are committing to attain the following:

- 21 To identify possible avenues and establish the basis of collaboration where it is mutually beneficial, however within the context of each party's mandate and existing technical, financial & legal obligations and further, without adversely affecting in any manner, the current corporate and legal relationships either party may have.
- 22 To this end, the Parties agree jointly to explore and coordinate activities of mutual interest that will be implemented in conformity with the regulations and policies of both Parties. The purpose is to establish a formal basis of cooperation between the Parties in a collaborative effort to promote skill development, information and knowledge delivery and capacity building.
- 23 Without limitation to the generality of the objective(s), the areas of collaboration will include:
 - 2.3.1 To promote Human Recourse development through different module of Training programme in the field of "**Sustainable Packaging for Food Products**" by providing technical knowledge and expertise to the students of the Department of Food Science & Technology of USTM with mutually agreed financial benefits.
 - 2.3.2 To support the research Projects related to the field of "**Sustainable Packaging for Food Products**" by way of providing technical expertise to meet the objective of the research project with mutual benefit.
 - 2.3.3 To establish an "**Incubation Centre**" in the field of "**Sustainable Packaging for Food Products**" for providing 'First-hand Knowledge' to the students of USTM and to stimulate for "Start-Up" business with sustainable approach.
 - 2.3.4 Creating a Centre of Excellence on "**Sustainable Packaging**" for stimulating entrepreneurial idea generation for high end products on display and provide information about where technical assistance, equipment, venture capital and other financing can be sourced. Relevant business plans and information about potential market linkages will also be made available. Help potential entrepreneurs undertake design and prototype development.

2.3.5 Identify and build **capacities of equipment/ inputs suppliers** that can help upgrade the products and processes significantly as per market requirements.

2.3.6 Both the parties may also support each other to provide **advisory support for technical and commercial appraisal** of the projects supported by their respective institutions.

2.3.7 Both the parties will complement information & knowledge that can be used to draw up policy inputs for presenting the same to the state governments and relevant national ministries through participation in events organised by either of the parties or jointly or by other parties where one of the two parties are invited to present their inputs.

Implementation Modalities: Implementation of specific projects on one or more areas will be listed in quarterly basis. After detailed study of its viabilities, FIPS will submit detailed project proposal highlighting the technological intervention, financial implications and outcome as benefit to the objectives of the collaboration. The project proposals will be vetted by the Competent Authorities of USTM as per its financial limit. Then the project will be implemented with close supervision of respective parties.

Article 3: General Terms of the MoU

3.1 Duration & Termination of the MoU

- 3.1.1 This MOU shall enter into force on the date of its signature by the authorised signatories of both Parties and shall remain in effect for a period of **3 years and extendable thereafter upon mutual agreement**, unless terminated by either Party with advance written notice to the other. It shall terminate thirty (30) days after receipt of such notice subject to settlement of all financial & legal issues between both the parties or as per clause 3.6 of this agreement. The MOU is renewable for another 5 years upon written mutual consent of both Parties, to be received one month prior to the expiry of the initial term. The renewal can be initiated by either party.
- 3.1.2 Notwithstanding its termination, the provisions of this MOU shall survive to the extent necessary to permit an orderly settlement of accounts between the Parties and to bring ongoing activities to a proper close with the least disruption to the pending work.
- 3.1.3 However, termination of this MOU shall not affect any other agreements that the Parties enter into unless such specific agreement also is terminated in terms of the provisions therein.
- 3.1.4 The Parties confirm that they shall exercise good faith in efforts to resolve any dispute between the Parties arising from or in connection with this MOU through mutual negotiations, consultations and mediation.

3.2 Technical & Financial Support

- Shall be decided mutually while designing the action on annual basis with detailing of the technical and financial contribution by both the parties, through separate consequential specific agreements as per technical, financial and legal terms of both parties.

- The consequential specific Agreements will be entered with all conditions of terms of USTM and FIPS having specific clause on Dispute/ Termination will be mutually agreed upon.

3.3 Confidentiality

- Each Party agrees to treat with the utmost confidentiality all documents, information and/or data obtained in the course of the execution of this MOU and deemed confidential by the other Party or which due to the nature of such information should be treated as confidential and shall not disclose same without the prior written confirmation of the party that disclosed the information unless compelled by a lawful order of a court of law or as a result of binding legislation.
- All confidential information submitted by one Party to the other shall remain the property of the Party from which it originates. Each Party shall return to the other all the Confidential Information received from the other Party and any copies thereof promptly upon request and one copy may be retained for archival purpose.

3.4 Exclusivity

The MOU is based on principle of non-exclusivity for both the parties. It means that each party is free to have similar arrangement with other party and no party will object to such kind of arrangement if entered into with any third party.

3.5 Settlement of Dispute/Termination Clause may be included in the project specific agreement when entered.

If any dispute or difference of any kind whatsoever arises between the parties in connection with this MOU or out of the breach, termination or invalidation of the MOU hereof FIPS& USTM shall attempt for a period of 30 days (or as usually accepted) after receipt of notice by the other party of the existence of a dispute in the first instance by mutual discussions between the parties.

3.6. Obligation upon termination

The rights and obligations of the parties thereto shall be settled by mutual discussion; the financial settlement if any shall take into consideration not only the expenditure incurred but also the expenditure committed by the parties hereto.



Memorandum of Understanding (MoU)

between

Gauhati University, Guwahati

and

University of Science and Technology, Meghalaya

This **Memorandum of Understanding (MoU)** is executed on this 7th Day of April, Two Thousand and Sixteen, between **Gauhati University**, Jalukbari, Guwahati- 781014, Assam - as the First Part;

And

University of Science and Technology, Meghalaya - as the Second part; herein together referred to as "**the Universities**".

Gauhati University, having its registered office at Jalukbari, Guwahati herein after called "**GU**" is a State University, established in 1948. The objective of the University is to strive to provide employment oriented higher education and promote research in areas which are of relevance in the state of Assam.

And

University of Science & Technology, Meghalaya, having its registered office at Techno City, 9th Mile, Baridua, Meghalaya, hereinafter called "**USTM**", is established by an act of Legislative Assembly of Meghalaya State in 2008. The objective of **USTM** is to impart world class education exploring opportunities and talents of north east region, thereby, creating cutting edge research centre and build a Knowledge Capital for societal development. **USTM** is an upcoming university with minimal resources and high ambition trying for academic excellence.

Whereas **USTM** has requested **GU** to mentor the upcoming university to achieve its objectives, through various programmes for the academic promotion and administrative guidance with the following identified fields but not limited to :

1. **Award of Ph. D Degrees** – The students who would like to register for Ph. D at **USTM** will be given option to opt for joint supervision – one from **USTM** and another from **GU**. Those faculties of **GU**, who are interested to be recognised as supervisor / Co-supervisor of **USTM**, shall apply for such recognition to the Controller of Examinations, **USTM**. Similarly, those faculties of **USTM** who are interested to be recognised as supervisor / Co-supervisor of **GU** shall apply for such recognition to the Controller of Examinations, Gauhati University. The competent authority of **the Universities** will consider such request on priority as per provisions of their rules.
2. **GU Faculty support to USTM** – Identified Faculty of **GU** in the areas of Applied Sciences, Biological Sciences, Environment Sciences, Business Sciences, Social Sciences, Engineering Sciences & Technology, Education and Law shall take classes at **USTM** for the identified courses and syllabus with mutual consultation by **USTM** faculty with **GU** Faculty. The **GU** faculty, who have agreed to take classes at **USTM**, shall be provided with Transport, Accommodation facilities and an honorarium per lecture as per **USTM** norms.
3. **GU to host selected USTM Students for short period** - **GU** will host students identified by **USTM** in different disciplines at **GU** for 10-15 days for attending special classes or regular classes with **GU** students in class rooms and laboratories as per the plan of **GU** to impart greater exposure in the respective subjects. During the period, **GU** will provide hostel accommodation to **USTM** students.
4. **Final Year Projects of USTM Students** – **GU** will permit some selected final year students of **USTM** on mutual consultation to do their Project Work at **GU**.
5. **Joint Submission of Collaborative Projects** – **GU** faculty will involve some of the selected faculty of **USTM** to be Co-investigator in their project proposals for funding and vice versa.
6. **Joint organization of Seminars/ symposia/workshop to be**– Some of the selected seminars / workshops / symposiums organized by the various departments of **GU** and **USTM** either by faculty or students to be held jointly on mutual consultation by the respective faculty on case to case basis.

7. **Facilitate the visitors of GU to visit USTM** - GU will try to request and facilitate the visitors / guests coming to GU to visit USTM also on their way.
8. **Guidance in University Administration** – USTM is an upcoming university and a beginner in many aspects. GU will provide guidance to USTM staff in Administration in areas like examination, admissions, recruitment of staff and organizing Convocation.
9. **Guidance in infrastructure development** - GU will guide USTM in upgrading of university infrastructure like laboratories, equipments, library, class rooms, recreational facilities, hostels, campus maintenance by providing necessary specifications and operational guidance wherever required.
10. **Sports promotion** – GU and USTM will conduct some inter university friendly matches in selected sports on mutual consultation.

Both GU and USTM agree that any information which is exchanged pursuant to this Memorandum of Understanding will be kept **strictly confidential** and used solely for the purpose, covered by this Memorandum of Understanding, unless such information was obtained by a third party who does not have an obligation of confidentiality toward the information-disclosing party and entered public domain.

Incidental expenses, if any with respect to the activities mentioned above will be met by USTM. Any expenditure w.r.t. visit of the GU staff to USTM will be met by USTM as per rule.

Subject to clauses below, both the Universities may **amend** this Memorandum of Understanding by mutual consent in writing. Any amendment agreed by the Universities shall come into effect from the date determined by the signing Universities on potential areas.

This Memorandum of Understanding shall **enter into force** on the date of signing and shall initially be valid for a period of three years. Thereafter, the Universities shall agree on mutual consent on the continued validity of this Memorandum of Understanding. However, GU has freedom to continue or discontinue the **MoU** at its own discretion.

The Universities agree that this Memorandum of Understanding shall enter into force on the basis of goodwill and shall not be legally bound. Nothing mentioned in this Memorandum of Understanding shall deem constitute partnership between the signing Universities appointing one party as an agent of the other. This Memorandum of Understanding will be effective upon signature by both the Chief Executive Officers for a period of three years, at which time will be reviewed for possible renewal for further three-year period. Either party may, on three (03) months notice in writing, terminate the MoU in advance of its normal expiration or request the recognition of its conditions.

THIS MEMORANDUM OF UNDERSTANDING is made on the 20th May, 2022

BETWEEN

University of Science & Technology, Meghalaya, having its registered office at Techno City, 9th Mile, Baridua, Meghalaya, hereinafter called "USTM", is established by an act of Legislative Assembly of Meghalaya State in 2008. The objective of USTM is to impart world class education exploring opportunities and talents of north east region, thereby, creating cutting edge research centre and build a Knowledge Capital for societal development. USTM is an upcoming university with minimal resources and high ambition trying for academic excellence.

AND

Guwahati Biotech Park (GBP), the first of its kind in Northeast India, is a visionary initiative launched by Government of Assam to promote business in biotechnology and allied areas through entrepreneurship development particularly in the North-Eastern region of the country.



The objectives of the park is to facilitate faster penetration of biotech industry and to accelerate the R & D activities in biotechnology and related fields with effective utilization of the rich natural resources of this region and to educate and utilize local human resources.

The park, in its first step, has set up an Incubation Centre namely Guwahati Biotech Park Incubation Center (GBPIC) in the temporary premises of the park at IIT Guwahati campus through a joint initiative of the Department of Biotechnology (DBT), Govt. of India, the Government of Assam, and the IIT Guwahati. The Incubation Centre has ready to use equipped laboratories which are being leased out to entrepreneurs/individual researchers to translate their research ideas into commercially viable technologies without risking huge investments in terms of infrastructure and equipments. The Incubation Centre has established a Central Analytical Instrumentation Facility and equipped laboratories for Medicinal Plant Extraction, Bio-prospecting, Micro-propagation, Fermentation and Bioinformatics are being developed and in order to share the facilities and expertise available in each other's institution herewith sign a Memorandum of Understanding and GBP herein referred to as SECOND PARTY.

1. Purpose and Objectives

The University of Science and Technology Meghalaya(USTM)and the Guwahati Biotech Park (GBP) desire and intend to develop co-operation and collaboration in research for development, training, and other agreed activities that further the aims and objectives of the Institutions as follows:

- a) To encourage, and use reasonable endeavors of each other to effect, without crossing the limitations of each other's resources, policies and procedures, visits from one Institution to the other by members of the academic, research and other staff for the purpose of participating in teaching, training, research for development programs and other agreed activities.
- b) To make use of GBP's facilities and services as per approved rates such as Sample testing (if applicable), Hiring Equipments, Leasing out space etc and in turn overall promotion of Biotechnology in the Northeast.
- c) To develop within the limitations of the Institution's resources, policies and procedures, collaborative work plans that specify the activities to be undertaken, objectives and targets, implementation mechanisms, roles and responsibilities, and resource contributions.
- d) To jointly explore external funding opportunities through project proposal development, thus enabling both Parties to expand and extend their collaborative activities.
- e) To provide, within the limitations of the Institutions' resources, policies and procedures, qualified students hosted by one institution access to research opportunities and/or degree programs at the other institution.



- f) To organize and conduct seminars, conferences, events, conclaves, annual conference and Business plan contest etc. in joint collaboration subject to the availability of funds.
- g) Conducting Hackathons or ideation events to encourage students to come up with ideas.
- h) To encourage the exchange of scientific materials, publications and information. The actual exchange of materials will be done on a purely voluntary basis and subject to required institutional Material Transfer Agreements.
- i) To encourage and support the start-up, incubation and development of innovation led, high growth knowledge based business in the multidisciplinary area of biotechnology.
- j) Incubates of both the organizations may avail the facilities may visit the incubators to avail trainings and learnings from the expert, in addition residential workshops can be organized for the incubatees of the incubators. However the costs incurred on the followings may be decided mutually.
- k) To provide formal and operational links with centers of knowledge creation such as National R&D laboratories, Universities, Medical Institutions and Research Organizations in India and abroad and create a strong network
- l) To facilitate creation/ development of new experimental and research/ training facilities through mutual co-operation of GBP and (Name of Organization) through exchange of experts etc.
- m) To sharing the infrastructure facility for conducting R & D works leading to entrepreneurial venture in biotechnology and allied areas as per mutually agreed terms and conditions.
- n) Make best efforts to support startups from the region with knowledge and access to resources (e.g. incubation facility, technology labs), so that innovative ideas can be transformed into successful business ventures.
- o) Charges/fees/rent for the services wherever required by the service provider institute will be paid by the user party as per mutually agreed terms and conditions.
- p) Exchange of human resources/facilities/services between both the parties will only be within the scope of the agreed terms and conditions and is for the duration of this MOU and may be extended subject to mutual agreement between the parties.
- q) Each party shall bear its own share of expenses and costs of travel, boarding and lodging (if applicable) with regard to all discussions and activities between the parties.

- r) Both parties shall coordinate to the extent possible, within the constraints of their Organization's security provisions, reasonable access to their respective facilities as needed to facilitate any activities.
- s) Providing endorsement, support, and dissemination of information on activities, projects, requests for participation, etc.
- t) Create a state-wide inclusive entrepreneurial ecosystem.
- u) Promote entrepreneurship create awareness, and motivate the youth.
- v) Facilitate external funding for startups.
- w) Provide Physical and virtual incubation services.
- x) Helping in creation of direct and indirect employment.

2. Understanding between the two Parties

- a) Both parties acknowledge the need to create an ecosystem for promoting innovation and entrepreneurship and are interested in partnering to further this cause.
- b) There is a need to inculcate an entrepreneurial & problem-solving mindset among the students and youth
- c) Both parties understand and shall strive towards creating a support structure within the organizations so that students can nurture innovative entrepreneurial ideas.

3. Non exclusivity

The relationship of the parties under this MOU shall be non-exclusive and both the parties, including their affiliates, subsidiaries, and divisions, are free to pursue other agreements or collaborations of any kind.

4. Assignment

It is understood by the Parties here in that this MOU is based on the professional competence and expertise of each party, and hence, neither Party shall transfer or assign this Agreement, or rights or obligations arising hereunder, either wholly or in part, to any third party.

5. Termination of MoU

This MOU commences from the date of last signing and shall be in force for 3 years. The MOU may be terminated at any time by mutual consent or by 6 months' notice by either party. It may



be amended, modified, extended, or renewed only by the written consent of both Parties. The Institutions agree to review this MOU six months prior to end of the 5-year term.

6. Confidentiality

- a) The parties to this MoU undertake to treat as CONFIDENTIAL AND PRIVILEGED information of the either party. The terms of confidentiality and mode of disclosure shall be as per mutually acceptable terms.
- b) Except as reasonably required, both the parties covenant that neither the party shall at any time during this MOU or at any time after it is terminated disclose or reveal to any person / organisation or otherwise make use of confidential information including any of the trade secrets, confidential operations, processes or dealings or any information concerning the parties and their subsidiaries, business, finances, transactions or affairs of the affiliates / agencies or any of their ventures which may come to the knowledge of either the party during the period.
- c) During the period of the MOU, each party agrees to respect each other's freedom of operation. Neither the parties shall interfere in the affairs / functioning of the other.

7. Dispute Resolution

- a) This MOU is not intended to create any legally binding obligations nor any financial commitment on either institution but, rather, is intended to facilitate discussions regarding general areas of cooperation as stated above.
- b) Any dispute occurring under the MoU shall be settled amicably through consultation between the two parties.
- c) Any issue which cannot be resolved within the general terms of MoU will sought to be resolved through Arbitration Proceeding involving the parties concern.
- d) In case any issue(s) demanding resolution beyond mutual settlement will be subject to local jurisdiction of the judicial proceeding within the State of Meghalaya (District- Ri Bhoi), India.

MEMORANDUM OF UNDERSTANDING

1. PREAMBLE

The Indian Institute of Technology Guwahati, incorporated under the Institute of Technology Act 1961 as amended by the Institute of Technology (Amendment) Act, 1994 and established in 1994, represented by its Director (hereinafter referred to as "IITG"). Indian Institute of Technology Guwahati, the sixth member of the IIT fraternity, commenced its academic programmes in 1995. IIT Guwahati is officially recognized as an Institute of National Importance by the Government of India

and

The **University of Science & Technology, Meghalaya**, having its registered office at Techno City, 9th Mile, Baridua, Meghalaya (hereinafter called "**USTM**") is established by an act of Legislative Assembly of Meghalaya State in the year 2008. The objective of USTM is to impart world class education exploring opportunities and talents of north east region, thereby, creating cutting edge research centre and build a Knowledge Capital for societal development. USTM is an upcoming university with minimal resources and high ambition trying for academic excellence.

INDIAN INSTITUTE OF TECHNOLOGY GUWAHATI (IITG) and UNIVERSITY OF SCIENCE & TECHNOLOGY MEGHALAYA (USTM), hereinafter collectively referred to as 'the Parties' and individually as 'the Party' formally agree on a Memorandum of Understanding (MoU) as follows:

The Director of Indian Institute of Technology Guwahati (IITG) and the Vice Chancellor of University of Science & Technology Meghalaya (USTM), for the purpose of furthering cooperation in education and R&D activities between these two institutions, hereby affirm their intent to promote such academic collaborations and to participate in various academic endeavors.

2. OBJECTIVES:

This MoU envisages the fulfilling of the following objectives:

- (a) **IITG administrative support to USTM:** Cooperation between IITG and USTM for improving or initiating new Bachelors, Masters and Doctoral programmes at USTM;
- (b) **Internship programme at IITG:** Under this programme, UG /PG/ PhD students of USTM will visit IITG for a period of 2 to 8 weeks to attend a summer internship programme either specifically designed and offered or as part of ongoing research at IITG. IITG may charge a fee per participant, on mutual agreeable terms, to cover the costs, if any;
- (c) **Visiting students:** IITG and USTM will explore possibilities of facilitating USTM students (at UG, PG and PhD level) to attend, as visiting students, semester long courses offered at IITG, as per terms of IITG including a fee as fixed by norms of IITG. USTM may work out its own mapping of credits for its own purpose of credit transfer.
- (d) **IITG Faculty support to USTM:** IITG may permit its faculty to visit USTM for short durations ranging from one week to one year to teach at USTM, on mutually agreeable terms, for capacity enhancement at USTM;
- (e) **USTM Faculty support to IITG:** IITG may consider requests from USTM Faculty to visit IITG as 'Visiting' Faculty members, as per their designations, for research and teaching activities at IITG for limited durations, on mutual agreeable terms.

- (f) **Short-term Training Programmes:** Development and organization of short-term training and certificate courses by IITG and enabling USTM faculty / staff / students to take part in ongoing continuing education programmes and courses of IITG;
- (g) **Enabling USTM faculty / students to pursue their Masters and Doctoral programmes** at IITG on a full-time basis, as per existing IITG norms;
- (h) Cooperation from IITG for **development of new areas of research and development** at USTM;
- (i) **Guidance in infrastructure development:** Extension of technical cooperation in the form of knowhow from IITG for infrastructural development, management and upgradation of library and teaching / research laboratories facilities at USTM;
- (j) To **jointly organize short term continuation programmes, seminars, conferences** on topics of mutual interest and invite faculty members from both the institution to participate.
- (k) Each of the institutions will maintain their independent identity, logo symbol, image and make no other claims in their publicity material, media, websites, which is termed to be beyond the scope and nature of activities as incorporated in this memorandum. Each party will consult with and take approval of the other party to use the latter's name, the names of the latter's officials'/faculty members, and the logo for the activities under this MoU, and dissemination of results, on a case-by-case basis.

3. COORDINATORS:

The Director, IITG and the Vice-Chancellor, USTM shall be primarily responsible for this cooperation at IITG and USTM, respectively. They may delegate their authority to coordinators whose responsibility will be to:

- (a) initiate action at their respective institutions to implement the provisions of this MoU.
- (b) coordinate and monitor the activities initiated under this MoU.
- (c) National regulations and customs shall be mutually respected.

4. GENERAL PROVISIONS:

- (a) This MoU shall have a duration of THREE years from the last date of signature, unless either party gives a six-month notice of termination. This MoU may be extended further, in five-year increments, after review and by mutual written agreement.
- (b) This MoU is a non-binding expression of the current intentions of the Parties, and neither Party will incur nor be bound to any legal obligations or expenses hereunder to the other Party until and unless definitive agreements have been negotiated and approved by the management levels of each Party.

5. FINANCIAL OBLIGATIONS:

There will be no financial obligations on both Parties under this agreement.

6. INTELLECTUAL PROPERTY:

IITG and USTM agree to respect each other's right to intellectual PROPERTY. Further, all rights linked to ideas, inventions and patents generated during the MoU, if any, shall remain the common intellectual property of the parties. The Parties shall not pass on or give usage rights of such property to any third Party without the consent of the other Party. Any such research collaboration to be taken up during due course of time under the ambit of this present MoU shall be legitimized by signing an agreement.

7. DISPUTE SETTLEMENT:

Any dispute, controversy, or claim arising out of or in relation to this MoU, including the validity, invalidity, breach or termination thereof, shall be settled by the parties amicably through mutual consultations and negotiations. In case of any legal dispute Gauhati High Court has the exclusive jurisdiction to solve the dispute.

8. FORCE MAJEURE:

A party prevented by force majeure from fulfilling its obligations shall not be deemed in breach of such obligations. The said party shall use all reasonable efforts to mitigate consequences of force majeure. At the same time, the Parties shall consult with each other on modalities of further execution of this Memorandum of Understanding. Force majeure as used in this Memorandum of Understanding is defined as acts of God, war (whether declared or not), invasion, revolution, insurrection, or other acts of a similar nature or force.

9. LIABILITY:

Except for loss or damages caused through gross negligence or intent, the Parties shall have no liability to each hereunder.

10. LEGAL RELATIONSHIP:

This MoU shall be construed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the parties. Nothing in this MoU shall be constructed to create any legal relationship between the Parties. Details of specific cooperation will be determined on a case by case basis and by mutual agreement consistent with this memorandum of understanding.

11. CONFIDENTIAL INFORMATION:

- (a) All information and documents to be exchanged pursuant to the MoU will be kept confidential by the Parties and will be used subject to such terms as each Party may specify. The Parties will not use the information for purposes other than that specified without the prior written consent of the other party.

- (b) All confidential Information shall remain the exclusive property of the disclosing Party. The Parties agree that this MoU and the disclosure of the Confidential Information do not grant or imply any license, interest or right to the Recipient in respect to any intellectual property right of the other Party.
- (c) Unpublished information, whether oral, in writing, or otherwise, discovered or conceived by the scientists or technicians and exchanged under the provisions of this MoU will not be transmitted to a third party, unless otherwise agreed by the Parties in writing.

4. Development of mutually beneficial academic programs, courses, and distance learning facilities;
5. Exchange of documentation and research materials in fields of mutual interest provided that, to the best knowledge of the respective institutions, there is no prohibition at law or otherwise against the exchange; and,
6. Exchange of students for study and research.

- A. Details of the implementation of any particular program shall be discussed and finalized separately, before undertaking the same
- B. For any program, TA/DA and local hospitality for faculty will be borne by the host organization, while students have to meet their expenses individually.
- C. Expenditure and income on any collaborative projects/programmes under this programme will be on sharing basis that could be mutually finalized.
- D. All the activities shall be carried out on cost basis as per the norms of the respective

institutions or on equal fund sharing basis if externally funded.

- E. Authorship/IPR will be on sharing basis that could be mutually finalized.
- F. This Memorandum of Understanding reflects the respective institutions' commitments to both educational and academic exchanges as of the date of the Memorandum of Understanding. This Memorandum of Understanding may be amended or terminated at any time by either party provided that notice of termination or amendment is provided by the notifying party to the other party within thirty (30) days of the date on which the termination or the amendment is intended to become effective. Any amendment or termination shall not have effect on any arrangement in place at the time that the notice is provided, where the arrangement arises from any Supplementary Agreements resulting from this Memorandum of Understanding.

Both institutions subscribe to the policy of equal opportunity and will not discriminate on the basis of gender, age, disability, race, color, religion, marital status, veteran's status, national or ethnic origin, or sexual orientation.

This Memorandum of understanding will become effective immediately. It shall continue in effect for a period of three years and may be extended by mutual agreement. It may be terminated by either institution upon one-year written notification to the partner institution.

Preamble

THIS DEED OF MEMORANDUM OF UNDERSTANDING is made on this the 30th day of September 2019 at Guwahati.

-AMONG-

Founded in 2011, the **University of Science & Technology, Meghalaya (USTM)**, Kiling Road, 9th Mile, G.S Road, Ribhoi, Baridua, Meghalaya 793101 is the first private science and technology university in the north-eastern region of India. The University is located in the Assam-Meghalaya border, 6 kms from Dispur, the capital of Assam and 85 kms from Shillong, the capital of Meghalaya state and is well connected by road, rail and air transport and is represented by its Chancellor **Shri Mahbubul Hoque**, hereinafter called "**FIRST PARTY/ USTM**" (which expression shall unless it be repugnant to the context or meaning thereof, mean and include its successors in office and assigns) on the One Part;

-AND-

INSTITUTE OF ADVANCED STUDY IN SCIENCE AND TECHNOLOGY (IASST), registered under Societies Registration Act, XXI, 1860, No.4219 of 1990-91, represented by its Director **Dr. Narayan Chandra Talukdar**, having its office at

Vigyan Path, Paschim Boragaon, P.O. & P.S. – Garchuk, Guwahati-781035, in the District of Kamrup (Metro), Assam, hereinafter called the “**SECOND PARTY/INSTITUTE/IASST**” (which expression shall unless it be repugnant to the context or meaning thereof, mean and include its successors in office and assigns) on the Other Part;

WHEREAS, the parties hereto have entered into this Memorandum of Understanding (MOU) for the purpose of “creation of a framework for collaboration between IASST and USTM” with the objectives as given below:

ARTICLE I: PURPOSE

This Memorandum of Understanding (MoU) is entered between USTM, Meghalaya and Institute of Advanced Study in Science and Technology (IASST) for the purpose of

- 1.1 Enhancing the teaching, learning and research experience of students and faculty in both the institutions in order to improve upon the quality of human resources available especially in Assam and the North-Eastern region of India;
- 1.2 Facilitating joint collaborative research works between students, faculty and staff of the two institutions, and registration of research scholars of IASST in USTM, Meghalaya as per the University Rules and Regulations.

ARTICLE II: AREAS OF COLLABORATION

The scope of collaboration under this MOU includes the following as governed by Rules and Regulations of both the institutions:

- 2.1 Faculty members/scientists in both the institutions may teach in either institution with prior approval of their parent institutions;
- 2.2 Faculty members/scientists in both the institutions may collaborate and jointly supervise research scholars in either institution;
- 2.3 The facilities of one institution will in principle be available to faculty members/scientists and research scholars of the other institution. The detailed modalities to be worked out on a case to case basis;
- 2.4 Research scholars students of IASST may register for a Ph.D. degree program under USTM, Meghalaya as per the Rules and Regulations of the University;
- 2.5 Courses offered by IASST may be recognized by USTM, Meghalaya and appropriate credits assigned to a particular paper(s) after due evaluation by the University: Entrance examinations for research scholars may also be organized jointly or recognized by USTM, Meghalaya if not done jointly after due scrutiny;

- 2.6 Both institutions shall endeavour to organise joint seminars, colloquium and other academic and outreach programs;
- 2.7 Both institutions shall endeavour to exchange relevant information in both academic and administrative matters in an unequivocal term;
- 2.8 Modalities for sharing of Intellectual Property Rights including applying for possible patents/publications for products developed as part of collaborative work between the two institutions should be agreed to in advance by the parties concerned, and approved by the appropriate authorities of both institutions.

ARTICLE III: DURATION, TERMINATION, AND AMENDMENT

- 3.1 This MoU shall have a term of five years from the date of execution, and may be modified from time to time by mutual agreement between the two institutions. This document is not meant to be a legally binding document, but is intended to provide a frame work for promotion of co-operation and collaboration between the two institutions in the best interests of the students and faculty/scientists of both institutions, and the larger interests of the community and the State. This MoU shall not diminish the full autonomy of either institution, nor may any constraints be imposed by either institution upon the other;
- 3.2 The MoU may be renewed after this period of five years.

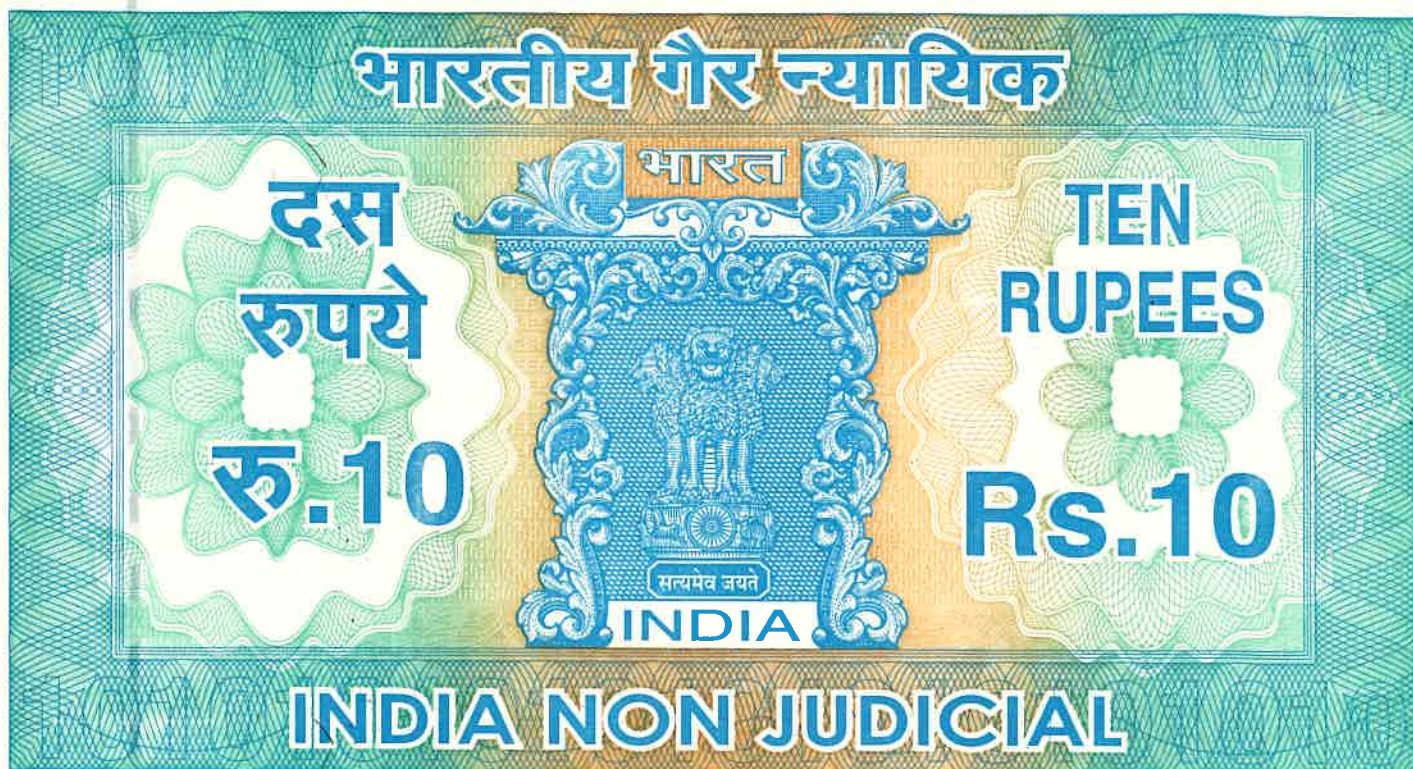

Memorandum of Understanding (MoU)
Between
Jawaharlal Nehru University, New Delhi
And
University of Science and Technology, Meghalaya

This Memorandum of Understanding (MoU) is executed on this 25th day of January, 2016 between Jawaharlal Nehru University, Delhi - as the First Part;

And

University of Science and Technology, 9th Mile, Baridua, Meghalaya - as the Second part; herein together referred to as "the University of Science & Technology, Meghalaya University (USTM).

Jawaharlal Nehru University (JNU) having its registered office at New Mehrauli Road, New Delhi, herein after called "JNU" a Central University, established by an Act of Parliament in 1966(53 of 1966).

And

University of Science & Technology, Meghalaya, having its registered office at Techno City, 9th Mile, Baridua, Meghalaya, hereinafter called "USTM", is established by an act of Legislative Assembly of Meghalaya State in 2008. The objective of USTM is to impart world class education exploring opportunities and talents of north east region, thereby, creating cutting edge research centre and build a Knowledge Capital for societal development. USTM is an upcoming university with minimal resources and high ambition trying for academic excellence.

Whereas USTM has requested JNU to mentor the upcoming university to achieve its objectives, through various programmes for the academic promotion and administrative guidance with the following identified but not limited to.

1. **Award of Ph. D Degrees** – The students who would like to register for Ph. D at USTM will be given option to opt for joint supervision – one from USTM and a co-guide from JNU. Those faculties of USTM who are interested to be recognised as supervisor / Co-supervisor of JNU, shall apply for such recognition to the Controller of Examinations, JNU. The competent authority of JNU will consider such request on priority as per provisions of JNU rules..



2. **JNU to host selected USTM Students for short period and vice versa** – JNU and USTM will host students Identified by respective Universities in different disciplines at **JNU/USTM under the student exchange** for attending special classes or regular classes with JNU/USTM students in class rooms and laboratories as per the plan of JNU/USTM to impart greater exposure in the respective subjects. During the period, JNU/USTM will try to provide decent hostel accommodation to all students, subject to availability of accommodation in JNU and prior intimation.
3. **North East Studies:** Both the Universities have agreed to work jointly on different issues of North Eastern region- covering its language, its varied cultural diversity, its food habits and its vast biodiversity.
4. **Final Year Projects of USTM Students** – JNU will permit some selected final year students of USTM on mutual consultation, to do their Project Work at JNU.
5. **Joint Submission of Collaborative Projects** – JNU faculty will involve some of the selected faculty of USTM to be Co-investigator in their project proposals for funding and vice versa.
6. **Seminars/ symposia/workshop to be jointly organized** – Some of the selected seminars / workshops / symposiums organized by the various departments of JNU and USTM either by faculty or students to be held jointly on mutual consultation by the respective faculty on case to case basis.
7. **Organize the visitors of JNU to visit USTM** - JNU will try to request and facilitate the visitors / guests coming to JNU to visit USTM also on their way.
8. **Guidance in University Administration** – USTM is an upcoming university and a beginner in many aspects. JNU will provide guidance to USTM staff in Administration in areas like, examination, admissions, recruitment of staff and organizing Convocation.
9. **Guidance in infrastructure development** - JNU will guide USTM in upgrading of university infrastructure like laboratories, equipments, library, class rooms, recreational facilities, hostels, campus maintenance by providing necessary specifications and operational guidance where required.
10. **Sports promotion** – JNU and USTM will conduct some inter university friendly matches in selected sports on mutual consultation.

Both JNU and USTM agree that any information which is exchanged pursuant to this Memorandum of Understanding will be kept strictly confidential and used solely for the purpose, covered by this Memorandum of Understanding, unless such information was



obtained by a third party who does not have an obligation of confidentiality toward the information-disclosing party and entered public domain.

Incidental expenses, if any with respect to the activities mentioned above will be solely met by USTM. Any expenditure w.r.t. visit of the JNU staff to USTM will also be met by USTM.

Subject to clauses below, both the **Universities** may amend this Memorandum of Understanding by mutual consent in writing. Any amendment agreed by the Universities shall come into effect on the date determined by the signing Universities on potential areas.

This Memorandum of Understanding shall enter into force on the date of signing and shall initially be valid for a period of three years. Thereafter, the **Universities** shall agree on mutual consent on the continued validity of this Memorandum of Understanding. *However, JNU has freedom to continue or discontinue the MOU at its own discretion*


The Universities agree that this Memorandum of Understanding shall enter into force on the basis of goodwill and shall not be legally bound. Nothing mentioned in this Memorandum of Understanding shall deem constitute partnership between the signing Universities appointing one party as an agent of the other. This Memorandum of Understanding will be effective upon signature by both the Chief Executive Officers for a period of three years, at which time will be reviewed for possible renewal for further three-year period. Either party may, on three (03) months notice in writing, terminate the MOU in advance of its normal expiration or request the recognition of its conditions.

Jurisdiction Clause

In case of any dispute arising out of this MOU between the parties, there will be the Grievances Redresses mechanism and civil court at Delhi shall have exclusive jurisdiction to try the matter/dispute.

This Memorandum of Understanding (MoU) is executed on this 25.09.2019

1. Parties

Mizoram University, A Central University, Mizoram, India – as the First Party;

And

University of Science and Technology, 9th Mile, Baridua, Meghalaya – as the Second party;
herein together referred to as “Exchanging Institutions” in agreement.

Mizoram University was established as a Central University by an Act of Parliament of India on 25th April 2000 and started functioning from 2nd July 2001. Prior to this, the University inherited from North-Eastern Hill University (NEHU) had functioned as Mizoram Campus for 24 year since 1979.

The main campus of Mizoram University rests on a plot of land measuring 978.1988 acres with its lush green scenic hills, at Tanhril, a village in the western outskirts of Aizawl City. It is now undergoing a sea change, and has embarked on various programmes / schemes in terms of academic, administrative and infrastructural development. It is pertinent to mention here that Mizoram University received nearly Rs. 170 Crores under GDG during the XIth Plan period and the amount has been fully utilized for creating a modern infrastructure, for teaching and research, and other support services.

And

University of Science & Technology, Meghalaya, having its registered office at Techno City, 9th Mile, Baridua, Meghalaya, hereinafter called "USTM", is established by an act of Legislative Assembly of Meghalaya State in 2008. The objective of USTM is to impart world class education exploring opportunities and talents of North East region, thereby, creating cutting edge research centre and build a Knowledge Capital for societal development. USTM is an upcoming University with minimal resources and high ambition trying for academic excellence.

2. Purpose

The purpose of this MoU to create a framework within the participating Institutions to seek and enrich their instructional programs and promote global awareness among their students. The exchanging Institutions, after approval by their responsible authorities, agree to pursue this agreement for academic cooperation/collaborations.

- i) The purpose of this agreement is to facilitate and to enhance the academic cooperation between the Exchanging Institutions.
- ii) The Exchanging Institutions shall promote direct academic contact between their students as well as academic teaching staffs and technical specialties.

3. Modes of Collaborations

The Exchanging Institutions shall endeavor to promote collaboration in various areas through a broad range of strategies, which in the initial stages may include but not be limited to:

- i) Academic exchanges of students, faculty and technical specialties.
- ii) The design of collaborative research projects, including the developmental of formal proposals for funding for such research.
- iii) Collaborative student projects, when feasible.
- iv) Collaborative applications for outside Extra mural funding, such as foundation or government grants.
- v) The exchange of students and professors for professional internships in regional enterprises.
- vi) Any expenditure incurred through the joint programme will be born as per mutual agreements.

4. Activities in Support of Collaboration

The Exchanging Institutions recognize the importance of certain ancillary in support of these areas of research and the technical collaboration. Principal among them shall be:

- i) The regular exchange of relevant publications and information generated by each of the Exchanging Institutions.
- ii) Regular communication concerning technologies and curriculum that will enable and enhance the substantive areas of collaboration referred to within this document.

5. Conditions for Collaboration

All collaborative efforts are by mutual agreement and in no way shall one Exchanging Institutions obligate the other.

- i) Nothing in this agreement shall create binding obligations on one Exchanging Institution by the other. All activities must be mutually agreed upon prior to the activity.
- ii) All participation by faculty or students in any aspect of these activities shall be entirely voluntary.
- iii) The outcome of the participating institutions in the form of Research Publications, Inventions and Patents shall be jointly shared by the Exchanging Institutions.
- iv) In formal negotiations, the Exchanging Institutions shall be represented by the Registrar of Mizoram University and the Director of USTM or their designees.
- v) Regularly employed personnel, while involved in activities under the Agreement, shall remain subject to the rules and regulations of their home institution in all matters of employment and benefits.

6. Terms of the Agreement:

This agreement shall become effective when the signatories representing both institutions have affixed their signatures, and shall be effective for a term of five years. The agreement is to be automatically renewed at the end of each five years terms, provided that neither institution gives written notice of the termination of this agreement to the other institution. This agreement may be revised with the mutual consent of both parties.



3.2. Unless otherwise extended by both the parties, the MoU shall be deemed to be terminated on expiry of the period mentioned above.





Understanding:

1. USTM becomes a partner of National Law University and Judicial Academy, Assam, for creating a win-win situation for mutual exchange of expert opinion and use infrastructure facilities under the following development programs:

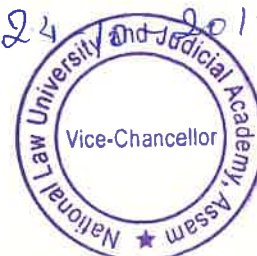

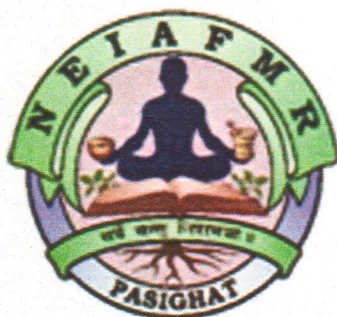

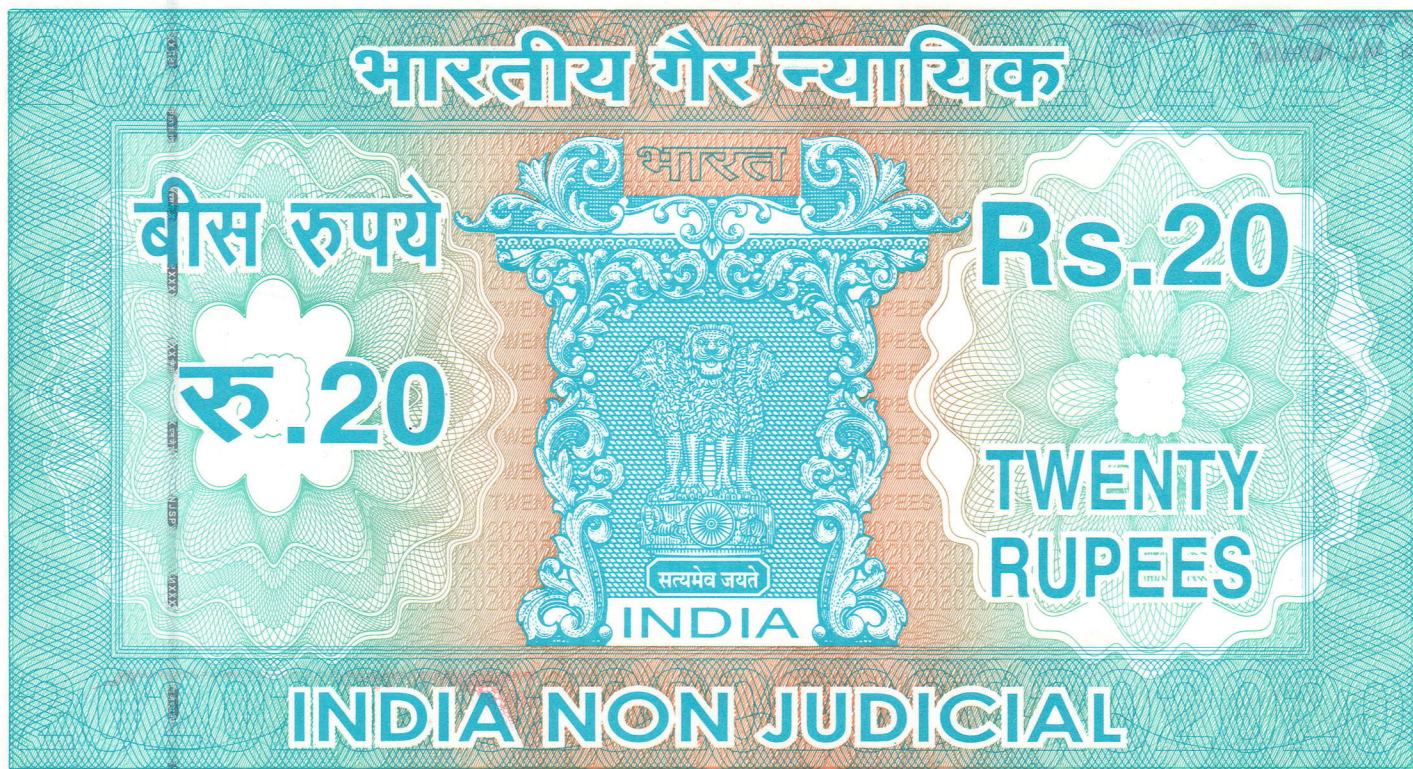

The Memorandum of Understanding (MoU) is drawn up and agreed upon to establish Academic and Research collaboration between The University of Science & Technology, Meghalaya – India hereafter referred to as USTM and North Eastern Institute of Ayurveda & Folk Medicine Research, Pasighat, Arunachal Pradesh– India hereafter referred to as NEIAFMR for the purpose of disseminating knowledge to the mutual benefits of both the Institutes.

The two parties recognize resource development and institutional capacity building as the basis of a mutually beneficial cooperative programme, hereinafter referred to as the Programme. This memorandum is established in the year 2022 for five years.

ARTICLE I: OBJECTIVES OF THE PROGRAMME

The objective of the Programme is to provide opportunities for collaborative Academic & Research work.

ARTICLE II: SCOPE OF THE PROGRAMME

The Programme initially is for five years which plans to provide collaborative co-operation through:

- a. **Collaborative research programs in specific fields of interest** – USTM, Meghalaya, and NEIAFMR, Arunachal Pradesh will jointly identify specific fields to conduct collaborative research programmes of mutual interest and benefits. Faculty/Scientist of both the institutes USTM, Meghalaya, and NEIAFMR, Arunachal Pradesh, will be recognized as Supervisor/Co-Supervisor for Ph.D. Programme from both the Organizations.
- b. **Student exchange programme** - Exchange programme for USTM, Meghalaya, and NEIAFMR, Arunachal Pradesh, students will be explored and conducted accordingly which will be mutually beneficial for both the parties. Launching of Joint Research Activities, the Exchange of Faculty Members/ Research Personnel will be explored and conducted.
- c. **Faculty/Scientist exchange programme** - Exchange programme for USTM, Meghalaya, and NEIAFMR, Arunachal Pradesh, Faculty/Scientist will be explored and conducted accordingly which will be mutually beneficial for both the parties.
- d. Exchange of Academic and other Publications, and
- e. Organization of Joint Conferences, Seminars and Academic Meetings.
- f. Any other form of co-operation that may be agreed upon between USTM, Meghalaya, and NEIAFMR, Arunachal Pradesh.

ARTICLE III: DURATION OF THE PROGRAMME

This Memorandum will be effective from the date of its signing by both the parties up to a period of the next five years. If this MoU is to be terminated without causes, a three months prior notice should be sent by either of the parties as applicable; This MoU may be renewed by mutual consent of both the institutions by written agreement.

ARTICLE IV: SPECIAL PROVISION

- Both parties shall exchange useful information on each other's educational, research training programmes and such other activities.
- Both parties hereto shall do their utmost to ensure the smooth and efficient

implementation of the Programme.

- Both parties shall exert best effort to be available for mutual consultation and shall be prepared to provide necessary information whenever reasonably requested.
- Any amendment to this MoU shall be made in writing and mutually agreed upon.
- All disputes arising in connection with the interpretation or application of this MoU shall be settled amicably through mutual negotiation.
- The two parties will maintain efficient communication in order to ensure the effective implementation of the Programme.

Terms of the memorandum:

Both the parties agree to carry out the above-mentioned activities in accordance with the law and regulation of the respective University and Institution after full consultation and approvals. The parties acknowledge that this MoU does not in any way give rise to any right or permission to use or to be associated with each party's intellectual property. Under collaborative research, any patentable research conducted by faculty or student in coordination with other parties, sharing of the intellectual property rights will be as per the IP Policy.

Confidentiality:

Each party shall undertake to observe the secrecy of confidential information received from or supplied to the other party during the research activities conducted within the period of implementation of this MoU or agreement made pursuant to this MoU.

For the purpose of MoU, "Confidential information" means any information whether prior to or hereinafter disclosed by a party (the receiving party) of this MoU involving technical, business, marketing, policy, know-how, planning project management and other information, data and/ or solution in any form.

All information known or received by a party to the other party to this MoU will be kept confidential and will not be disclosed to any third person.

Settlement of Disputes:

- a) Any difference or dispute between the parties concerning the interpretation and/ or application of any of the provisions of this MoU shall first be settled amicably through mutual consultation and/or negotiation between the parties.

- b) Any issue which cannot be resolved within general terms of MoU will be sought to be resolved through Arbitration Proceedings involving the parties concerned.
- c) In case any issue(s) demanding resolution beyond mutual settlement will be subject to local jurisdiction of the judicial proceeding within the State of Meghalaya (District Ri-Bhoi), India and State of Arunachal Pradesh (District East Siang), India.

Revision, Variation and Amendment:

Either party may request in writing a revision, variation or amendment of this MoU. Any such revision, variation of the amendment agreed to by parties shall be in writing and shall form part of this MoU. Such revision, variation of amendment shall come into force on such date as may be determined by the parties. A minimum period of six months' notice will be required from either party wishing to terminate or amend this agreement. In the event of termination, the relevant parties will honour all commitments to students participating in the Programme.

This MoU is prepared in two identical copies; each party will hold one original copy duly signed by the respective Vice Chancellor/ Head of the Institute. This agreement shall take the effect from the date of signing by both the parties.

This Memorandum of Understanding is made and executed on the **27th day of the month of April, 2015** between **University of Science & Technology, Meghalaya** situated in Techno City, 9th Mile, Baridua, Ri-Bhoi, Meghalaya, hereinafter referred as **USTM**. The university is established under **Act 6 of 2008 enacted by the State Legislative Assembly of Meghalaya and incorporated under section 22 & 2 (f) of the UGC Act 1956.**

And

North Eastern Space Applications Centre (NESAC), a premier institute established by the **Department of Space, Government of India and North Eastern Council** to work in the area of applications of space science and technology in the North Eastern Region of India, hereinafter referred as **NESAC**. The office of **NESAC** is situated at Umiam, Ri Bhoi district, Meghalaya.

Preamble

University of Science & Technology, Meghalaya (USTM) have its registered office at Techno City, 9th Mile, Baridua, Ri-Bhoi, Meghalaya is established by an act of Legislative Assembly of Meghalaya State in 2008. The objective of **USTM** is to provide high class education of modern age exploring opportunities and talents of the North East Region, thereby, creating cutting edge research centre and build a **Knowledge Hub** for societal development. **USTM** is an upcoming university with enormous potentialities and high ambition trying for academic excellence. Considering education as the backbone of a healthy society, **USTM** intend to produce future leaders and policy makers of tomorrow for fulfillment of dreams of the country especially for the NE Region.

North Eastern Space Applications Centre (NESAC) is a joint initiative of Department of Space (DOS) and the North Eastern Council (NEC) to provide developmental support to the north eastern region (NER) of our country using space science and technology. The major objectives of the Centre are: i) to provide an operational remote sensing based natural resource information base to assist activities on development / management of natural resources and infrastructure planning in the region ii) to provide operational satellite communication applications services in the region in education, health care, disaster management support, and

developmental communication and iii) to establish a space science and climatic change research hub by installation of necessary instrumentation and networking with various academic institutions of NER.

Purpose & Objectives:

The purpose of this MoU is to create a framework for collaboration between USTM and NESAC with the objectives as given below:

1. To establish close linkage and functional coordination between USTM and NESAC.
2. To recognize NESAC as an accredited research centre for research and study directed by USTM and vice versa.
3. To consider the scientists, designated scholars and management professionals of NESAC as an accredited faculty/supervisor for different research, teaching and management programmes of USTM subjected to their meeting the basic criteria.
4. To facilitate joint seeking of funds, submission of project proposals for research and development, training, consultancy and project management with funding agencies.
5. USTM and NESAC shall meet the expenses for the respective purposes and activities under this MoU from their own resources.

The MoU will be governed by the following conditions:

1. USTM and NESAC shall support each other towards the advancement of knowledge and R&D activities of the employees, faculty, scholars and students of both the organizations.
2. USTM will provide all facilities to the employees (Scientific and Technical staff) and scholars (Research Fellows and Project Assistants) of NESAC to enroll for Ph.D. programme at the USTM under joint supervision as per university admission procedure.
3. NESAC shall facilitate the students, scholars and faculties of USTM to conduct studies and researches required for partial fulfillment of requirements leading to the award of PG and Ph.D. degree by USTM. Number of candidates to be taken up under each of the degrees at a time shall depend upon the availability of supervising scientists and laboratory space. **Director, NESAC** shall be the ultimate authority to decide in such cases.
4. NESAC shall, subject to availability extend facilities to a limited number of M.Sc./M.A. students of USTM for short duration summer/winter training courses at NESAC under the relevant guidelines. **Director, NESAC** shall be the ultimate authority to decide the topics and number of participants.
5. USTM shall provide scope to interested Scientists of NESAC, to teach certain portions of PG courses at its campus. Necessary honorarium to the resource person shall be paid by USTM as per the guidelines to the scientists of NESAC.
6. **On mutual agreement**, diploma programmes, specialized and short duration refresher courses, training and skill development programmes, and project management courses on

topics of interest to the Government/Industry/Academia and other space based R&D activities can be jointly offered at USTM or NESAC.

7. USTM and NESAC will encourage and provide facilities to the faculty members of USTM and scientists of NESAC to explore and prepare joint research proposals on some thrust areas for funding by government and other agencies. The technical activities and grant sharing between two parties shall be defined and mutually agreed while submitting such proposals.
8. Any intellectual property arising out of the joint intellectual input under a collaborative R&D project will be held jointly, filling and maintenance cost of which shall also shared equally. The responsibility of filing and maintaining the intellectual property shall be of NESAC. However, in the event of licensing of the IP for commercialization by USTM or NESAC to any Party, the fund accrued or likely to be accrued will be shared between USTM and NESAC at a proportion to be mutually decided from case to case basis after deducting the cost of patenting borne by NESAC on behalf of USTM. In case, USTM does not want to be a party to the intellectual property, Director, NESAC shall take an appropriate decision regarding its filling and utilization, and **vice versa**.
9. USTM shall not file any application for seeking Intellectual Property Rights in its own name or in the name of its associates or any other person on any matter relating to the information gathered/disclosed to it by NESAC and **vice versa**.
10. USTM and NESAC shall consult each other for any publication in respect of any project/research work. These publications shall be in the names of researchers as per intellectual contribution and as per the publication guidelines of the respective guidelines, wherein it will be duly acknowledged that the work has been carried out at USTM or NESAC under the sponsorship of the sponsor.
11. USTM and NESAC shall extend their library facilities to the scientists, faculty members, research scholars and students in accordance with the rules and regulations that govern the functioning of their respective libraries.
12. Apart from the aforesaid academic, management and research work, USTM and NESAC shall collaborate in the following areas as mutually agreed upon from time to time.
 - Dissemination and updating knowledge of research work being carried out through technical activities such as training programmes, seminars, symposia, workshops, publication of papers, conventions, conferences at various levels.
 - Social issues.
 - Natural Resources, Disaster Management Plans, Meteorological works, Biodiversity and Wildlife researches, Environmental and Geographical researches.
 - Recognition and rewards to individual as well as organizational achievements in scientific research, conservational activities, technology and entrepreneurship, visiting faculties.
 - Any other crucial areas of common interest.
13. This MoU is valid for a period of five years term from the date of signing of the MoU and can be extended through proper renewal on the recommendation of the review committee. The MoU will automatically lapse after five years, unless renewed.

14. The progress of work and outcome of this MoU will be monitored annually by the review committee constituted as below:

1. **Chairman:** Vice Chancellor, USTM.
2. **Co-Chairman:** Director, NESAC.
3. Two representatives from USTM.
4. Two representatives from NESAC.





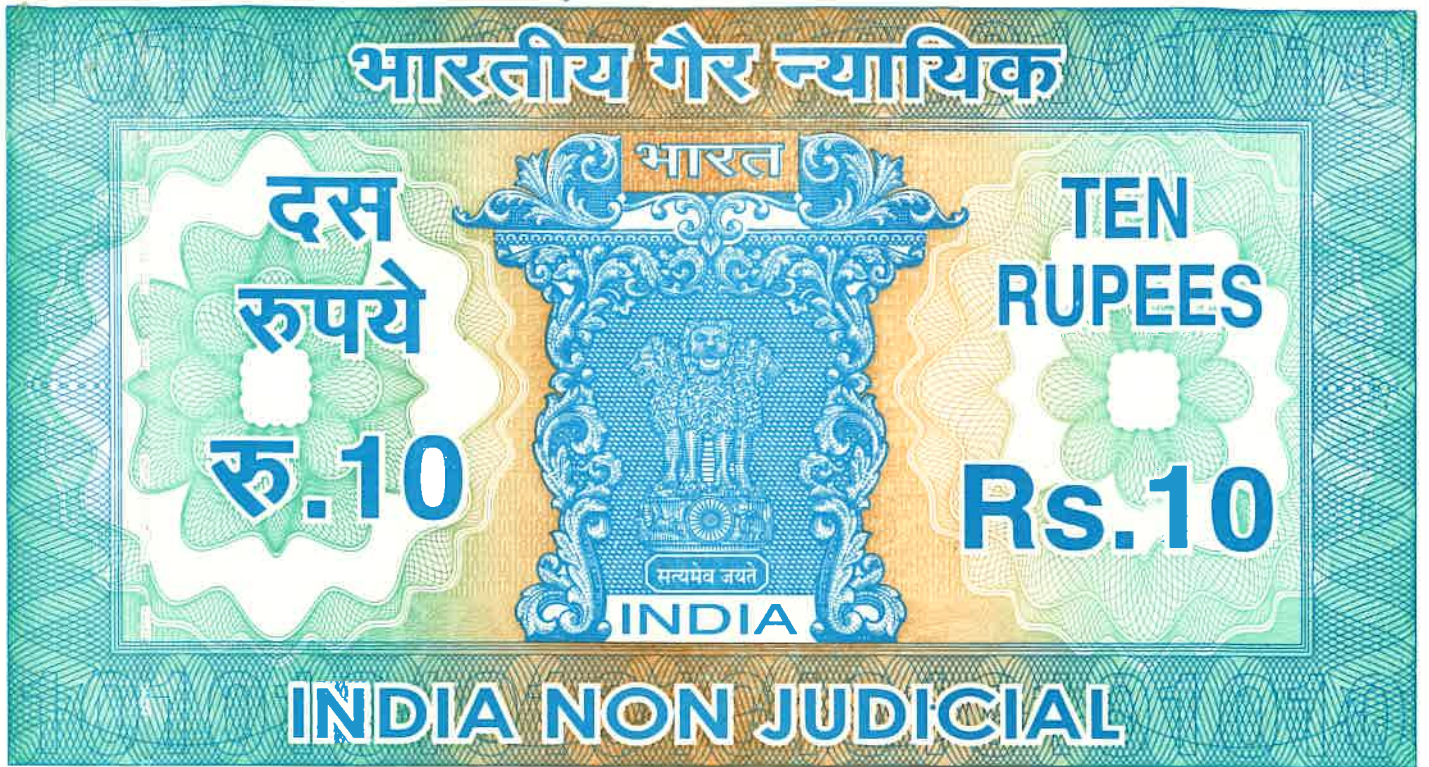

A. Preamble

The **State Council of Science Technology & Environment (SCSTE), Meghalaya** was constituted by the Government of Meghalaya on the 30th January, 1995 and was registered under the Meghalaya Societies Registration Act, 1983. The Council was established with a mission to ensure effective utilization of science & technology for all round development of the State and its main function is to identify, formulate, execute/coordinate and follow-up programmes/schemes for the State on various aspects of science & technology. Meghalaya along with the rest of Science & Technology (S&T) Councils in the Country has taken the initiatives to set up the Patent Information Centre (PIC) which is also a mandate of the Department of Science & Technology (DST), Government of India. The Patent Information Centre (PIC) SCSTE became functional in the year 2019 supported by Meghalaya Basin Development Authority (MBDA) and Planning Department, Government of Meghalaya to foster IPR activities in the State with the following objectives:

- To create awareness about IPR's especially patents in the State of Meghalaya.
- Enable patent and trademark searches for the Universities, Industry, Government Departments and R&D institutions in the State.
- Analyse the patent information on a regular basis and suggest new programme for R&D based on such information.
- Guide the inventors in respect of patenting their inventions, protecting creation and trademark.
- Catalysing protection of GI's in the State.

The PIC also facilitates formation of IPR cells within the Universities in order to achieve more IPR related activities at the University level in particular and at the public level in general.

Whereas **University of Science Technology, Meghalaya (USTM)** has been established under the provisions of the University of Science and Technology, Meghalaya Act (No.6 of 2008) enacted by Legislative Assembly of Meghalaya and notified vide Gazette Notification No LL(B)87/2008/21, dated 02.12.2008 of Government of Meghalaya.

The University is empowered by the University Grants Commission, to award degrees as specified by the UGC under section 22 of the UGC Act, 1956. USTM has also received necessary approval from AICTE, New Delhi; NCTE, ERC, Bhubaneswar, Pharmacy Council of India to run MBA, B.Ed. & B. Pharm courses respectively.

The university has set up a Centre for Innovation, Incubation and Entrepreneurship and is involved in high value research emphasizing required needs as well as in pursuing frontier areas of research innovation. Invention and entrepreneurship have remained the primary focus. The University is directing all its efforts to create the much needed S & T manpower to foster relentlessly the economic and social development of the region in an inclusive manner.

As a result of this, **University of Science Technology Meghalaya (USTM)**, hereinafter called the 'Recipient' will continue the activity of the established Intellectual Property Rights (IPR) Cells with the technical support from **State Council of Science Technology and Environment (SCSTE) Meghalaya**. Both the Recipient and Patent Information Centre (PIC), State Council of Science Technology and Environment (SCSTE) agreed to the following norms for setting up the IPR Cells as a collaborative effort.

B. Objectives of this IPR Cell would be:

Objectives:

1. To create an awareness about IPRs for the students, researchers, and faculties of your institute.
2. To provide information to students, researchers, faculties, and other people of the region regarding patent filling and patentability of their work.
3. To organize awareness programs in collaboration with PIC, SCSTE in its campus and associated institutions.
4. To extent support for Geographical Indication (GI), Copyrights, proper documentation for Traditional Knowledge Digital Library (TKDL) etc.
5. To conduct workshops, seminars, etc. for the promotion of research and innovation related activities.

C. Effective Date, Duration and Termination of the Agreement

1. The agreement shall be effective from the date of signing and shall remain in force for the period of 3 years.
2. On expiry of the above mentioned period, the agreement shall terminate or can be renewed for another definite period of time with the agreement of both parties.
3. It may be terminated by either party giving three months prior notice to the other party in writing. The termination of the MoU shall not affect any activities already in progress.

D. Responsibilities of the Recipient:

1. The Recipient agrees to continue the activity of the IPR Cell and run it in an efficient manner to meet the objectives stated above.
2. The Recipient shall provide the space for the IPR Cell

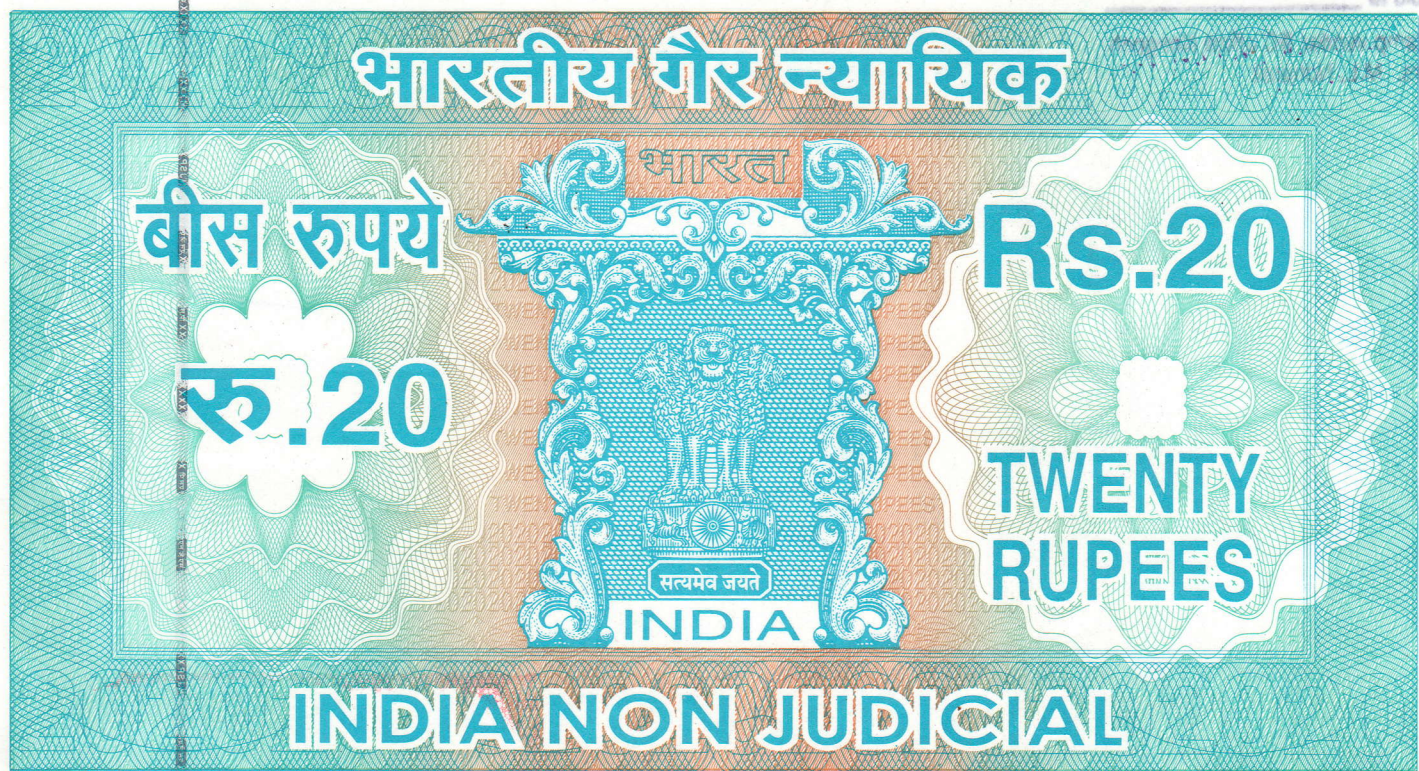

Preamble:

The University of Science and Technology, Meghalaya (Science and Technology, Meghalaya) was established under the provisions of the Meghalaya Legislative Assembly under act no. 6 of 2008 notified vide gazette notification no. LL(B) 87/2008/21, dated 02-12-2008 of Government of Meghalaya. The University is empowered by the UGC to award the degree as specified under section 22 of UGC Act 1956.

UNESCO Association – Guwahati was established in 1997. It was established to promote knowledge and create awareness about the ideals of UNESCO amongst the people through education, science and technology, culture and communication. UAG is having special consultative status with UN- ECOSOC and associated with department of UN Secretariat. UAG has its representatives at UN Headquarters in New York, UN- Geneva and UN- Vienna.

Objectives:

The objectives of this agreement are to promote cooperation between USTM and UAG. The mutual cooperation will enable the utilization of each other's strengths which in turn, will mutually benefit the students and faculty and other members of both the organizations and to create a platform for such collaboration, UAG and USTM, Meghalaya have agreed to the following as given below:

1. **Purpose:** It is the MOU for the cooperating parties to give on the development of the University in the field of education, science, culture and environment and sustainable development.
2. **Areas of cooperation:**
USTM has agreed to assist the UAG of its program to be executed in the university in the following areas:
 - a. UAG will promote UN programs to be executed by USTM in the university.
 - b. USTM will execute the activities/programs of UAG while UAG will support USTM to execute it.
 - c. UAG will set up a UN reading library at USTM while USTM will provide space exclusively for it.
 - d. USTM will nominate a person from University as a part of delegation for the international conferences if required.
 - e. USTM may provide conference hall/ training hall to UAG for its program jointly.
 - f. UAG and USTM will support and provide help to each other in undertaking any study/ research related to sustainable development activities in North – East region in India.
 - g. USTM will coordinate and cooperate to promote activities of Youth hostel Associations of India, such as membership, UN international days observation, tracking, cycling expeditions, student's educational outreach programs, sport related and cultural activity.
 - h. USTM and UAG will support and cooperate with each other in undertaking any study/research related to sustainable development activities.

3. Role of USTM, Meghalaya:

- a. To provide infrastructural and relevant facilities for the successful implementation of the abovementioned objectives.
- b. To facilitate the organization for different programs in the institute premises through mutual discussion.
- c. The members of UNESCO Association- Guwahati will be able to access the library facility of USTM.

4. Role of UNESCO-Association Guwahati

- a. To provide infrastructural and relevant facilities for the successful implementation of the above mentioned objectives.
- b. To facilitate the organization for different programs in the institute premises through mutual discussion.
- c. The members of USTM, Meghalaya will be able to access the library facility of UNESCO Association, Guwahati.

5. Implementation of the MOU:

The “cooperating parties” shall remit within their respective capacities, mandate and resources, shall make the necessary arrangement to ensure mutually satisfactory implementation of the MOU.

6. General Provisions:

The MOU shall be effective upon signature by both the parties, for a period of 3 years from the date of signature. The MOU may be extended beyond the period upon mutual consent of both the parties.

The topics for Ph.D. work shall be from the ongoing research programmes at **AARANYAK** within the academic structure of **USTM**.
3. **AARANYAK** shall provide necessary facility to the students and faculty of University of Science and Technology (**USTM**) to conduct research required for partial fulfillment of requirements leading to the award of Ph.D. degree by **USTM**. Number of candidates to be taken up under each of the degrees at a time shall depend upon the availability of supervising scientists and laboratory space. Secretary General and CEO, **AARANYAK** shall be the ultimate authority to decide such number.

6. On mutual agreement, specialized and short duration refresher courses, training programmes and project management courses on topics of interest to the Government/Industry/Academia can be jointly offered at **USTM** or **AARANYAK**
7. **USTM** and **AARANYAK** will encourage and provide facilities to the faculty members of **USTM** and scientists of **AARANYAK** to explore and prepare joint research proposals on some thrust areas for funding by government agencies. The technical activities and grant sharing between two parties shall be defined and mutually agreed while submitting such proposals.
8. Any intellectual property arising out of the joint intellectual input under a collaborative R&D project will be held jointly, filling and maintenance cost of which shall also shared equally. The responsibility of filing and maintaining the intellectual property shall be of **Aaranyak**. However, in the event of licensing of the IP for commercialization by **USTM** or **AARANYAK** to any Party, the money accrued and likely to be accrued will be shared between **USTM** and **AARANYAK** at a proportion to be mutually decided from case to case basis after deducting the cost of patenting borne by **Aaranyak** on behalf of **USTM**. 11. **USTM** and **AARANYAK** shall extend their library facilities to the scientists, faculty members, research scholars and students in accordance with the rules and regulations that govern the functioning of their respective libraries.
12. Apart from the aforesaid academic, management and research work, **USTM** and **AARANYAK** shall collaborate in the following areas as mutually agreed upon from time to time.
 - Dissemination and updating knowledge of research work being carried out in North East through technical activities such as seminars, symposia, workshops, publication of papers, conventions, conferences at various levels.
 - Social issues.
 - Water Resources and Disaster Management
