Entry of vehicles to campus

The following points are to be followed strictly for entry of vehicles to the University Campus:

- 1) Only authorized vehicles having "entry pass" will be allowed to enter the University Campus. Others have to register in the main gate before entry.
- 2) Commercial heavy vehicles will not be allowed to enter the campus from 8 am to 5 pm.
- 3) Speed limit of vehicles within the campus should not exceed 20 kmph.
- 4) Vehicles without pass need to produce pollution certificate at the time of registration in the gate.
- 5) Noisy vehicles will not be allowed to enter the campus.
